














Employment/Enrollment before Incarceration








Type of Substance Abuse




























Recidivism by Prior Felonies in Nevada


Recidivism by Habitual Offender Status


Recidivism by County of Conviction










Male Population Trends









Admissions and Releases Trends







Changes in Population
