The change in methodology may have caused a small shift in the frequencies that fall in each group relative to former editions of this report.

Data Limitations:

Data published in this report were extracted from a live database; thus, it is possible that figures reported in tables and charts do not balance to totals reported in other reports published by the Nevada Department of Corrections (NDOC). Select distributions consist of estimates and are susceptible to rounding error and missing data that could have caused these distributions not to add up to exactly 100%. Current fiscal year data for the NDOC or for other agencies are not always available at time of edition; consequently, the NDOC performed its best effort to align data accordingly to derived estimates.

Unless specified, figures in this report are retrieved from the Nevada Department of Corrections InfoView data warehouse and from the Nevada Department of Corrections Offender Tracking System (NOTIS).

Length Employed or in Training Before Incarceration





Female Population Projection Comparison State Fiscal Year 2022












Monthly Fluctuation in Prison Moves








Summary of Macroeconomic and Employment Indicators

- Unemployment continued to improve by declining from a seasonally adjusted rate of 8.1% at the end of the first quarter to 7.8% by the end of the second quarter of Calendar Year 2021 and to 7.5% by the thirdquarter. The seasonally adjusted rate was still 3.8 percentage points above the impressive pre-pandemic rate of 3.7%.
- Per-capita income during the second quarter of CY 2021 in Nevada increased \$3,345 or 6.65% relative to the fourth quarter of CY 2020.
- Protective service occupations is a large occupational group that encompasses various sub-groups, such as police officers, firefighters, animal control workers, correctional officers employed by various industries and public sector, and first-line supervisors in the group.
- It is estimated that during Calendar Year 2021, in Nevada 44,476 workers will be employed in protective service occupations across all industries who earn a a mean wage of \$23.26 per hour or \$48,370 per year. This occupational group is projected to reach 46,350 by the end of CY2028, an increase or 4.21%. The estimate for correctional officers and jailers and first-line supervisors of this subgroup for this calendar year was revised downward from 3,114 to 2,809. The most current earnings data available is as of May 2020, reflects that correctional officers and jailers earn a mean hourly wage of \$31.33 and an annual salary of \$58,340, both above the US hourly wage of \$26.01 and yearly salary of \$54,115 for the correctional and jail officer group.
- For Fiscal Year 2022, which began in July 2021, the Nevada Legislature authorized 890 non-custody and 1,865 custody full-time positions, a decrease of 20 custody and 45 non-custody positions from Fiscal Year 2021. The decrease in funded positions is associated with a sginficantly lower prison population.
- At the end of September 2021, 1,549 security and 841 non-security positions were filled by NDOC. Filled positions have been below budgeted positions for various reasons, such as the ability to recruit officers in remote areas of the state, retirements, and the effect of the COVID-19 pandemic which resulted in labor shortages.

The largest increase in crime in Nevada was in arson, with the rate rising 47.87%, while for the U.S., the greatest increase was in homicide rising by 27.45%.



>Nevada shares common characteristics with all of the U.S. in that property is the major crime category and homicide the lowest.






