The Prison Rape Elimination Act (PREA) requires that the Department review collected data related to PREA for each institution and facility "...in order to assess and improve the effectiveness of its sexual abuse prevention, detection, and response policies, practices and training..." The data collected should include identifying problem areas and identifying the on-going corrective action taken by the Department and each of its facilities and institutions.

In conjunction with PREA standard §115.88:

Substandard (a)(3), the Department shall also "...prepare an annual report of its findings and corrective actions for each facility, as well as the agency as a whole.

(a)(3)(b) "Such report shall include a comparison of the current year's data and corrective actions with those from prior years and shall provide an assessment of the [Department's] progress in addressing sexual abuse.

(a)(3)(c) "The Department's report shall be approved by the [Department] head and made readily available to the public through its website..."

This report is intended to provide information and comparison for calendar year 2014 compared to the data collected for the previous calendar year of 2013 for the agency and each of its institutions and facilities along with information about accomplishments and/or adjustments to date during calendar year 2014.

The final rule for PREA was published in the Federal Register on June 20, 2012, and became effective August 20, 2012. The standard that governs external audits provides that the first three year audit cycle begins on August 20, 2013. The final Audit Compliance Tool was officially released in final form during the middle part of calendar years 2014. Thus the Department began its preparations in earnest towards compliance late calendar year 2013 then on-going during calendar year 2014, a list of findings and corrective actions will be documented for the department and each of its institutions and facilities in the next annual report.


Department Achievements in 2014

Department achievements for 2014 included:

- The continuation of criminal background checks of all new employees, contractors, and volunteers which began August of 2012;
- Continued review and revision of all Department's staff education block of instruction related to PREA;
- On-going review and revision of Department's Administrative Regulations (AR) impacted by PREA standards;
- Compliance in background checks and a block of education for certain contractors and all volunteers, depending upon the amount of time a contractor spends with or around inmates;
- Application and receipt of Justice Assistance Grant in order to send identified IG staff to PREA certified Auditor training at PREA Resource Center;
- Initiation and participation in Western States Consortium/Circular Audit;
- First round of facilities and institutions for certified audit with the accomplishment of 100% compliance; and
- Continued implementation of processes and practices at facilities and institutions related to PREA.
