The Prison Rape Elimination Act (PREA) requires that the Department review collected data related to PREA for each institution and facility "...in order to assess and improve the effectiveness of its sexual abuse prevention, detection, and response policies, practices and training..." The data collected should include identifying problem areas and identifying the on-going corrective action taken by the Department and each of its facilities and institutions.

**In conjunction with PREA standard §115.88:**

**Substandard (a)(3), the Department shall also "...prepare an annual report of its findings and corrective actions for each facility, as well as the agency as a whole.**

**(a)(3)(b) "Such report shall include a comparison of the current year's data and corrective actions with those from prior years and shall provide an assessment of the [Department's] progress in addressing sexual abuse.**

**(a)(3)(c) "The Department's report shall be approved by the [Department] head and made readily available to the public through its website..."**

This report is intended to provide information and comparison for calendar year 2017 compared to the data collected for calendar year 2016 for the agency and each of its institutions and facilities along with information about accomplishments to date during calendar year 2017.

The Federal Prison Rape Elimination Act (PREA) of 2003 was established to address the sexual abuse and sexual harassment of offender in confinement settings. On August 20, 2012, the PREA Standards Final Rule, to help prevent, detect and respond to sexual violence, staff sexual misconduct, and sexual harassment behind bars was released.

Nevada Department of Corrections PREA policy establishes a zero tolerance for sexual abuse, staff sexual misconduct, and sexual harassment. The policy provides guidance for the prevention, detection, response, investigation, and tracking of all allegations.

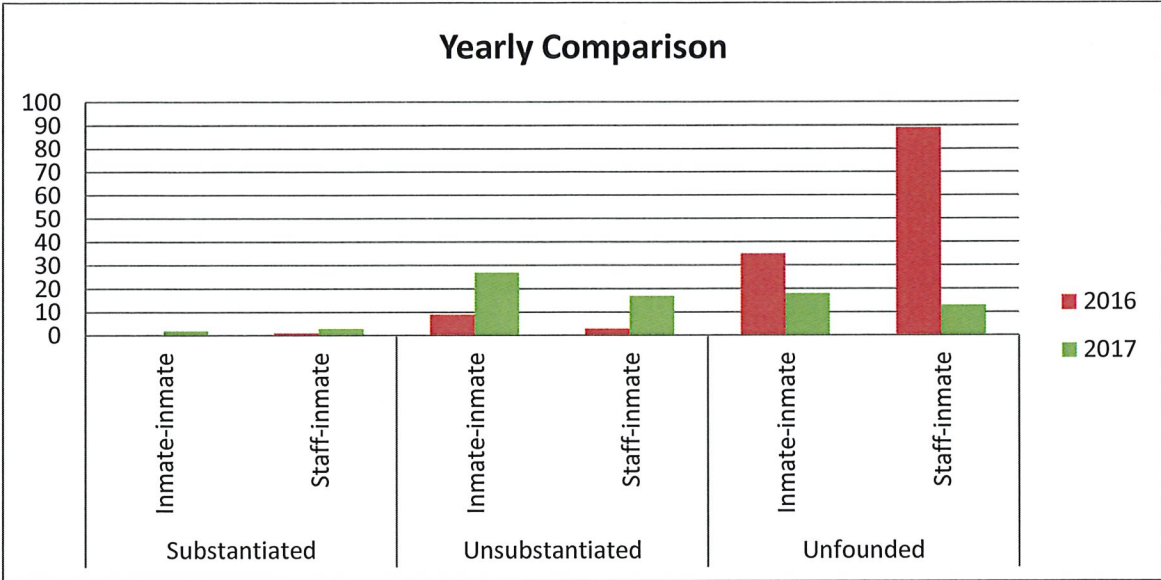
NDOC continues to progress in addressing sexual safety of all inmates who are incarcerated within the agency and continually monitors all allegations of staff on inmate and inmate on inmate sexual abuse and sexual harassment. Each allegation is investigated by trained investigators and reviewed by the Inspector General or Criminal Investigator Supervisor.

**Department Achievements in 2017**

- The continuation of criminal background checks of all current employees seeking promotion, which began August of 2012;
- Developed staff education block of instruction related to universal pat searches for both in-service training for current employees and Pre-service training for new employees;
- Implemented an enhancement to our current computer based classification tool to include an objective PREA risk screening assessment tool;
- On-going review, revision and update to the Administrative Regulations impacted by PREA standards or updates to the PRC FAQs;
- Apply for and receive the Justice Assistance Grant through Department of Justice for the PREA Re-allocation funding (NDOC was found to be compliant, however not all executive reporting branches were);
- Internal audit and inspections for those facilities or institutions going through or who will be going through Certified external audit;
- On-going training of staff, inmates, screenings and services in order to maintain compliance; and
- Annual PREA Compliance Manager 2 day training.
