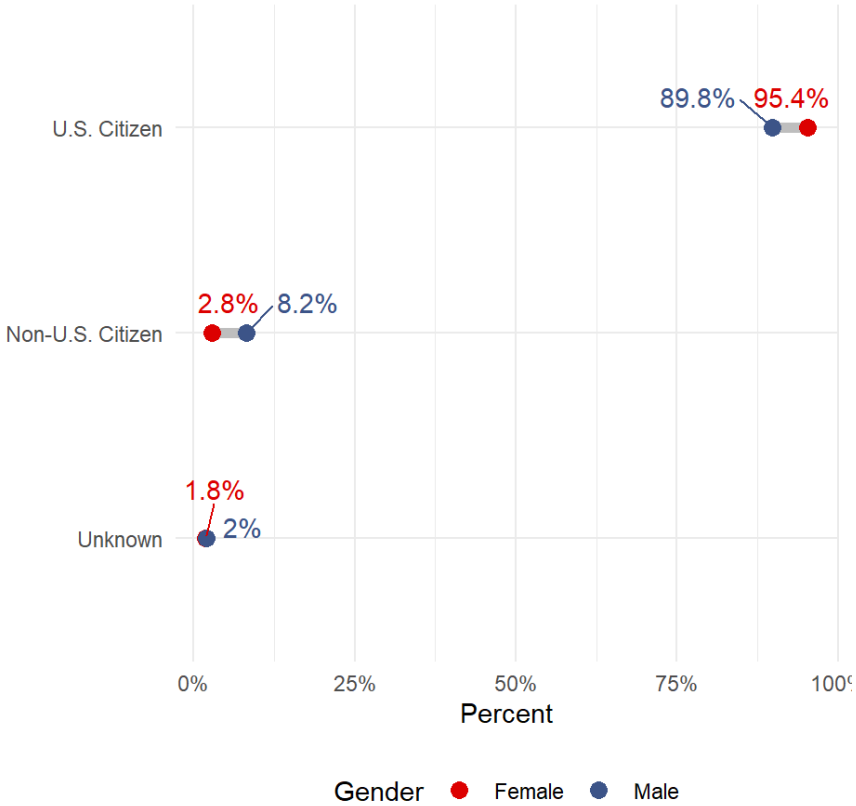

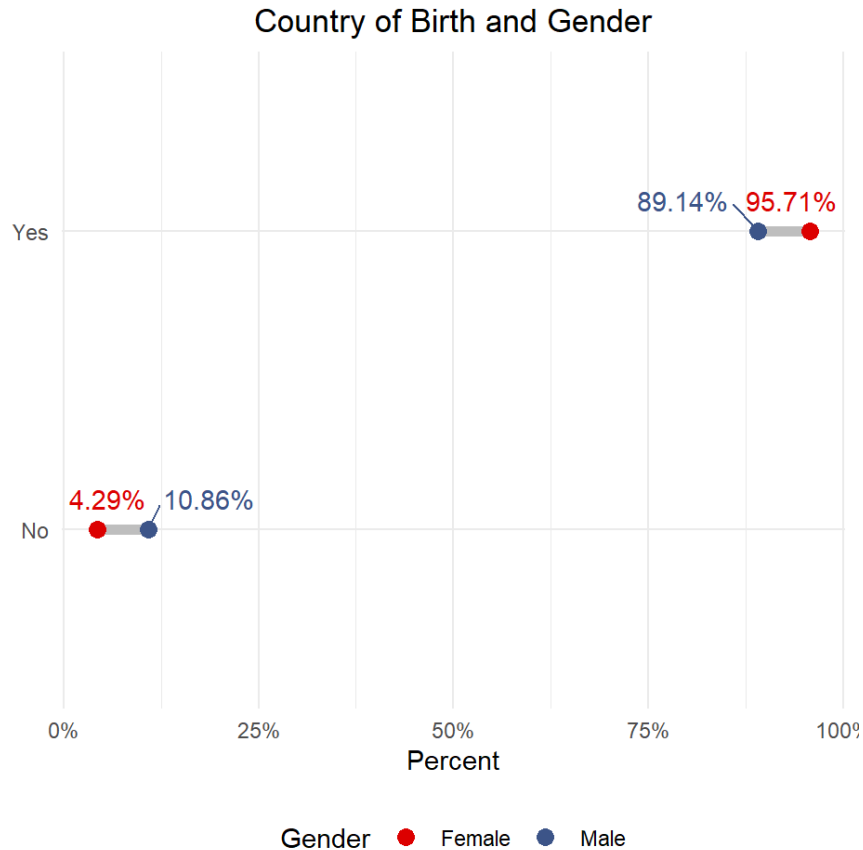

Country of Birth



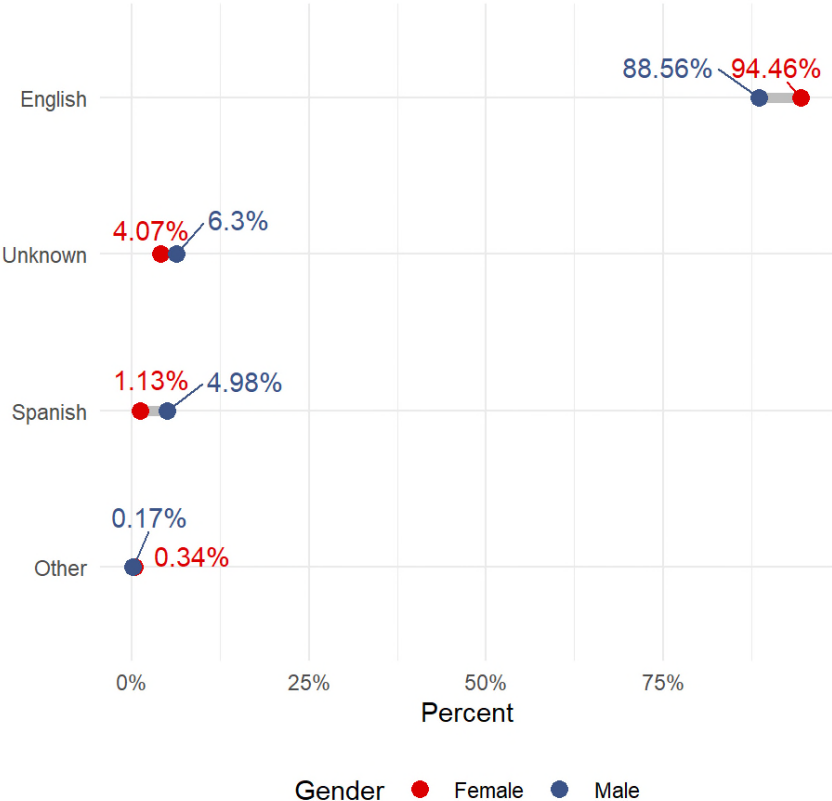

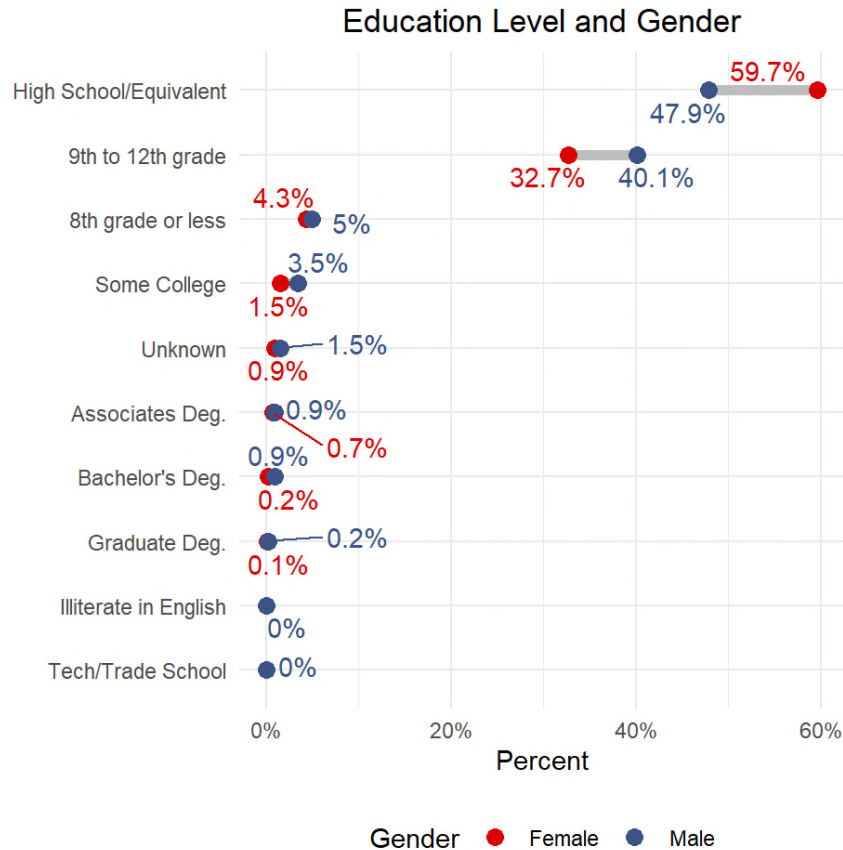

Education Level at Intake

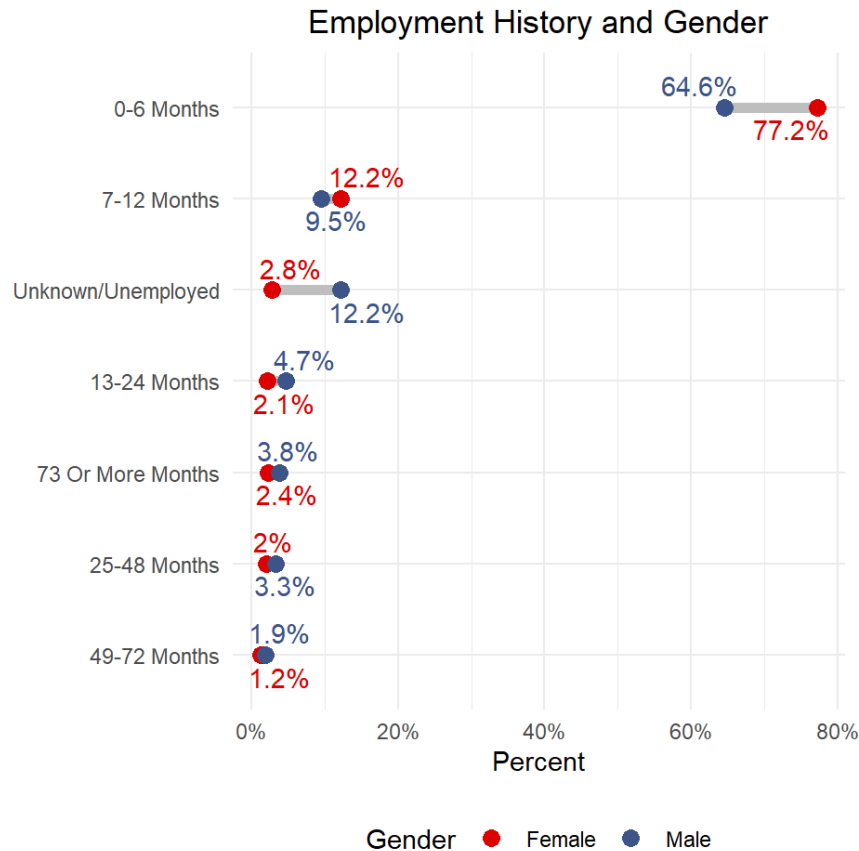

Employment/Enrollment before Incarceration

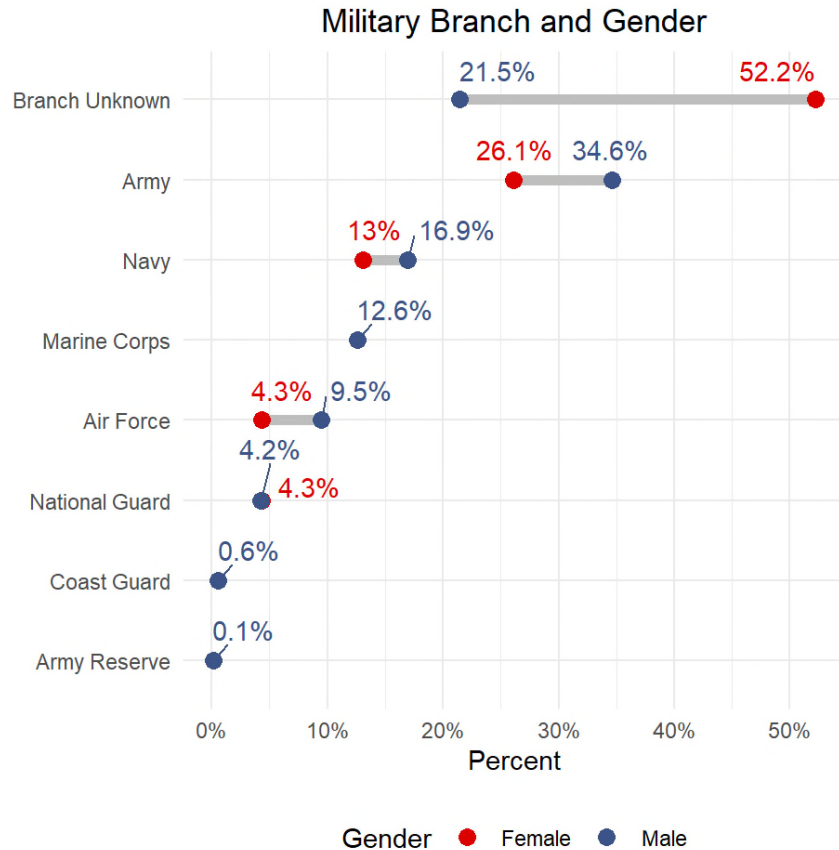

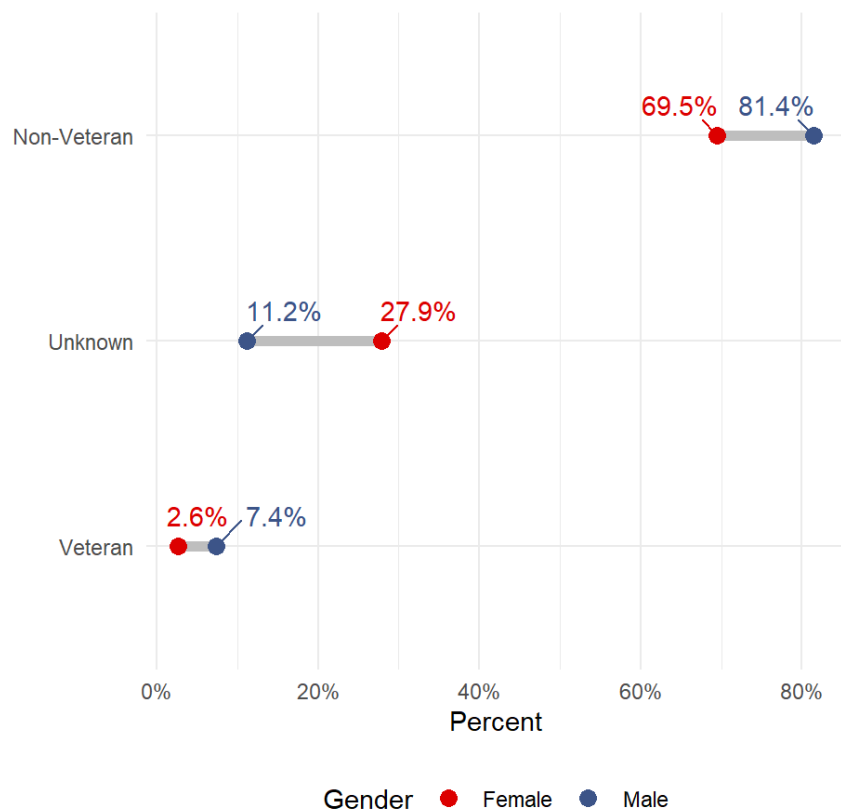

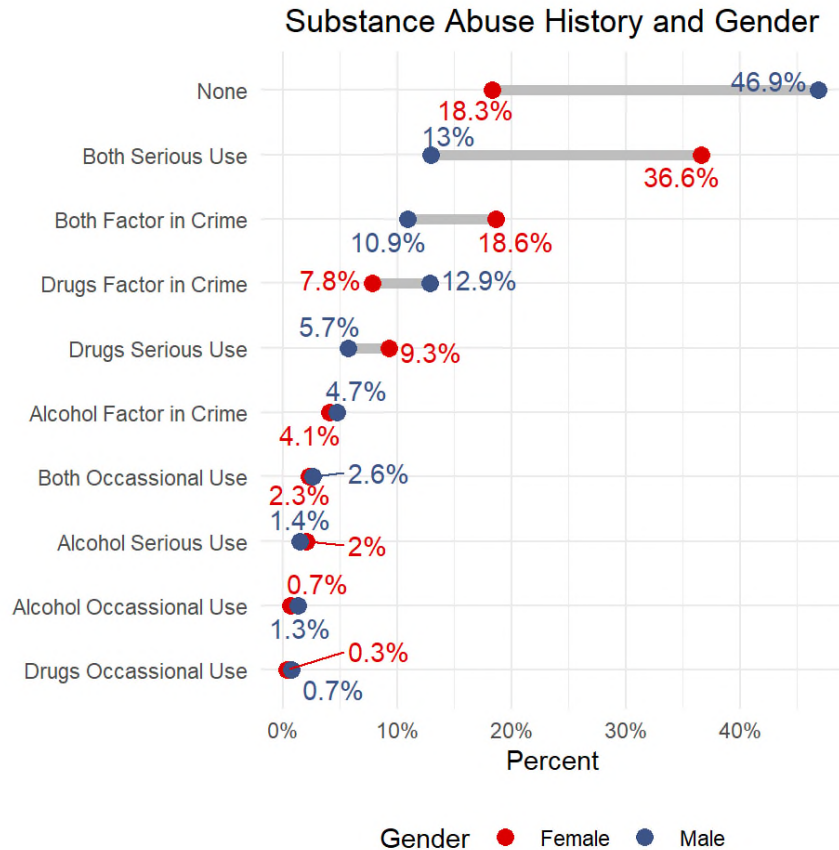

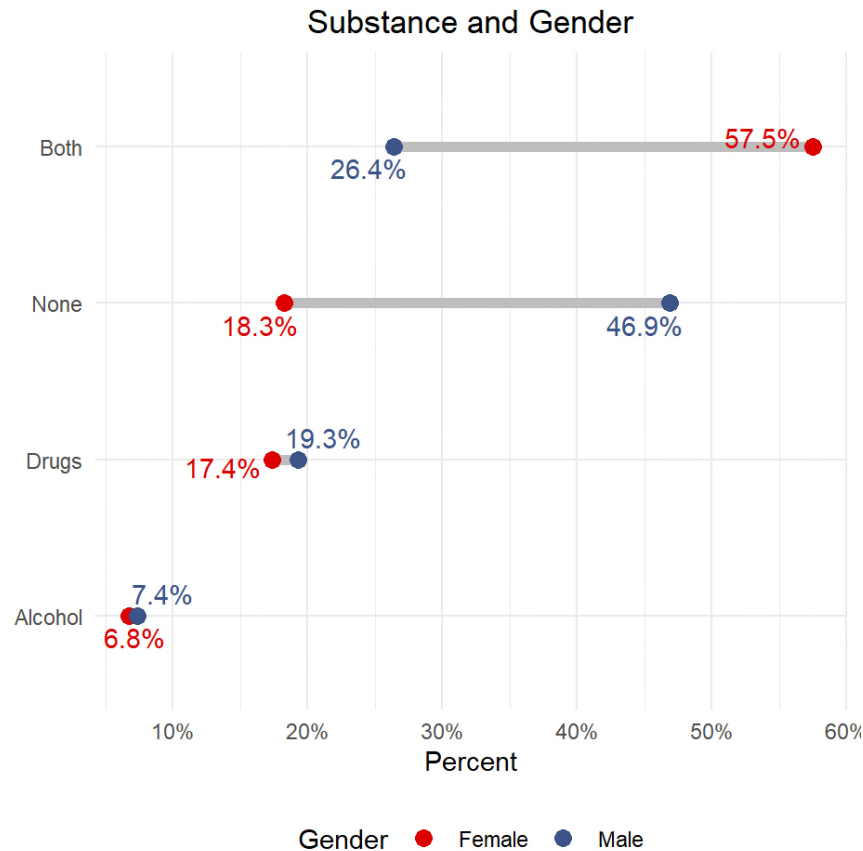

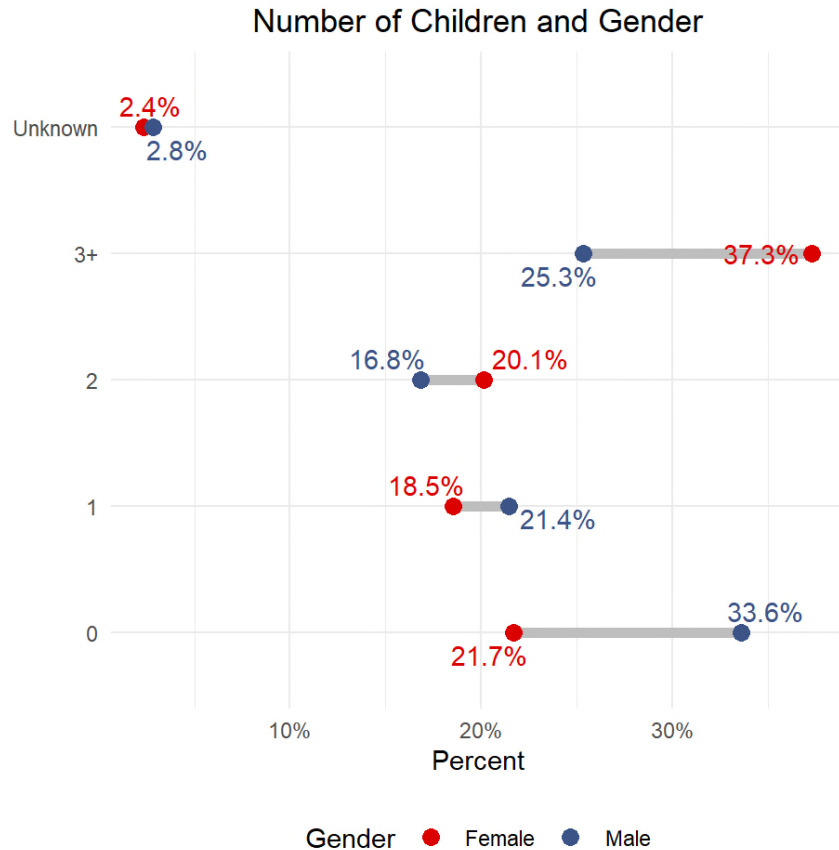

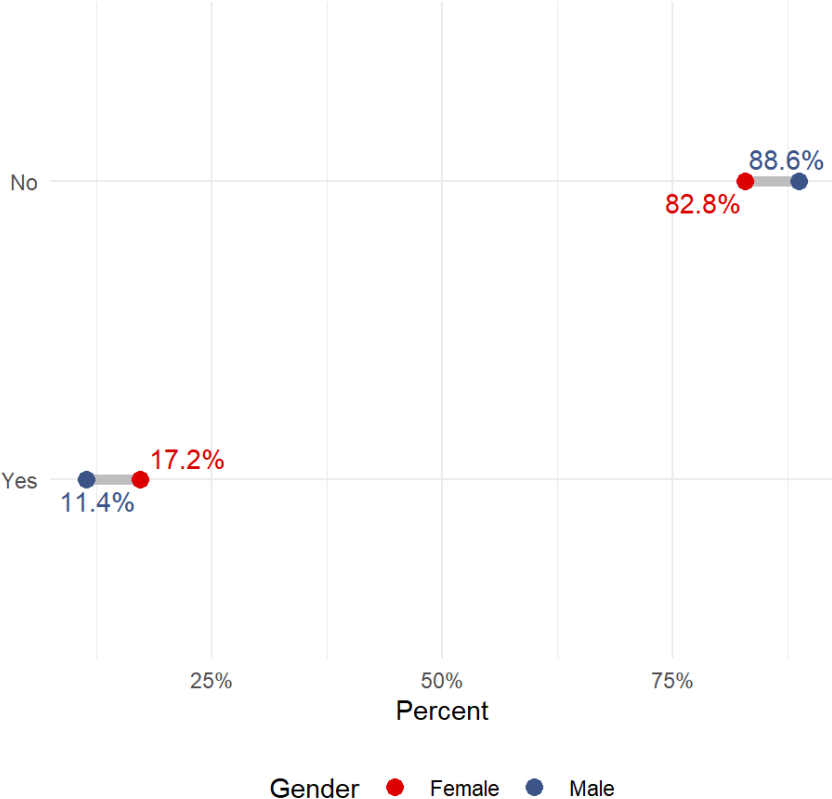

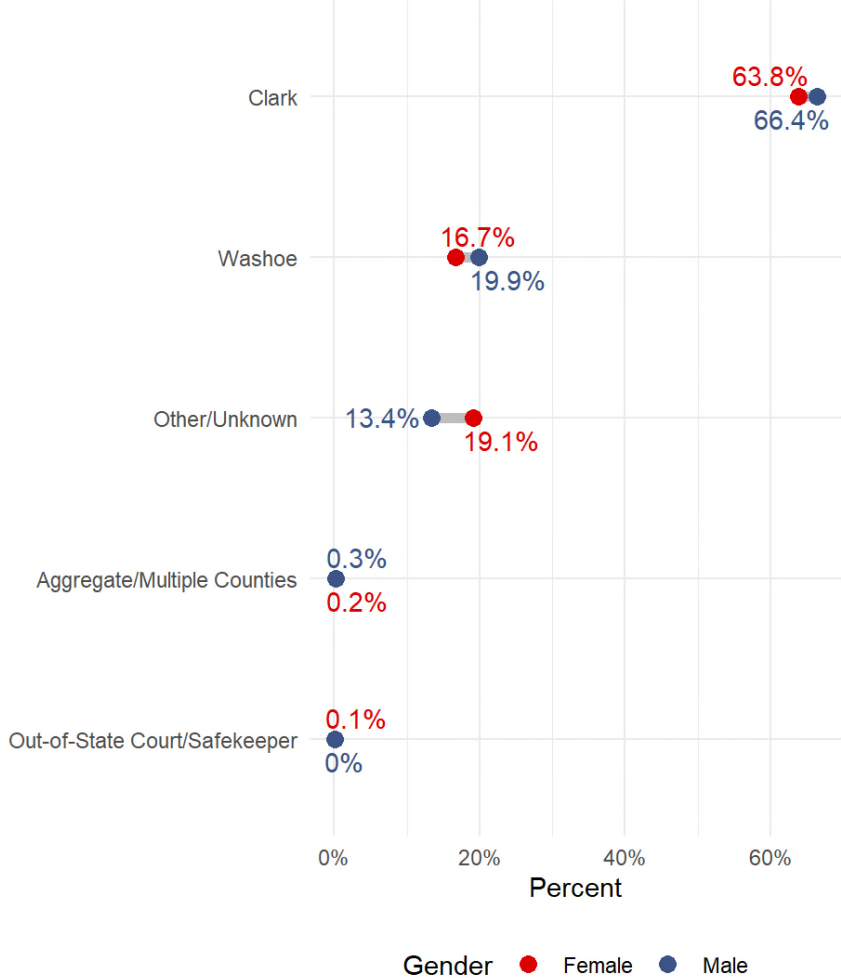

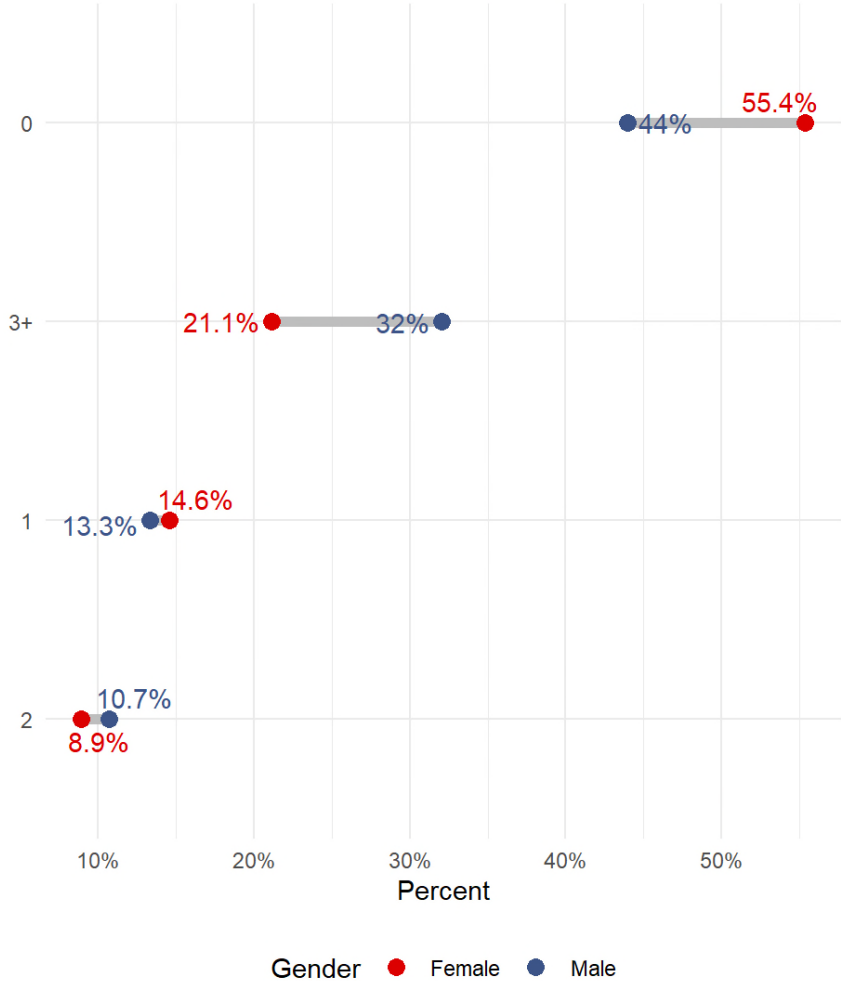

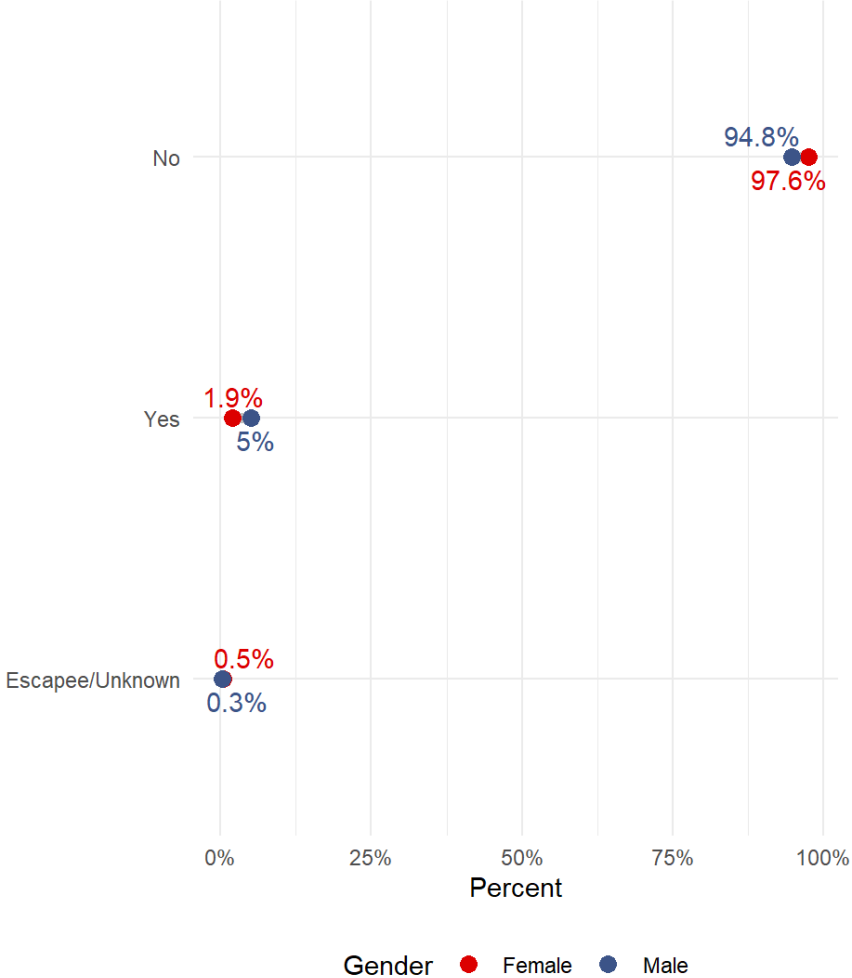

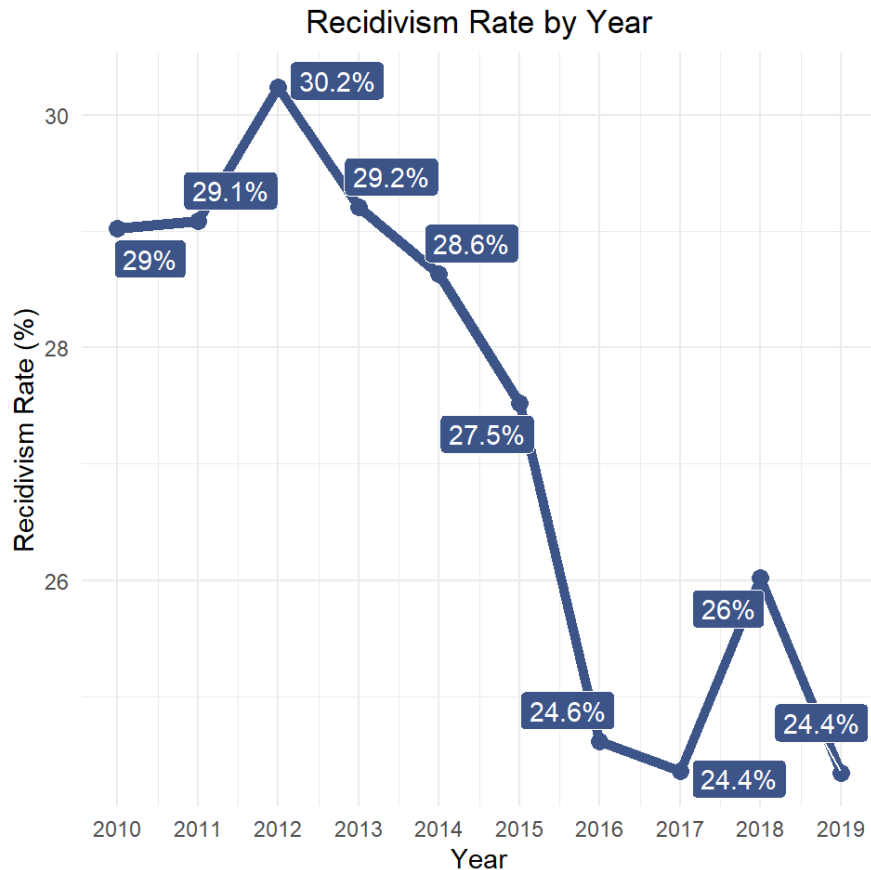

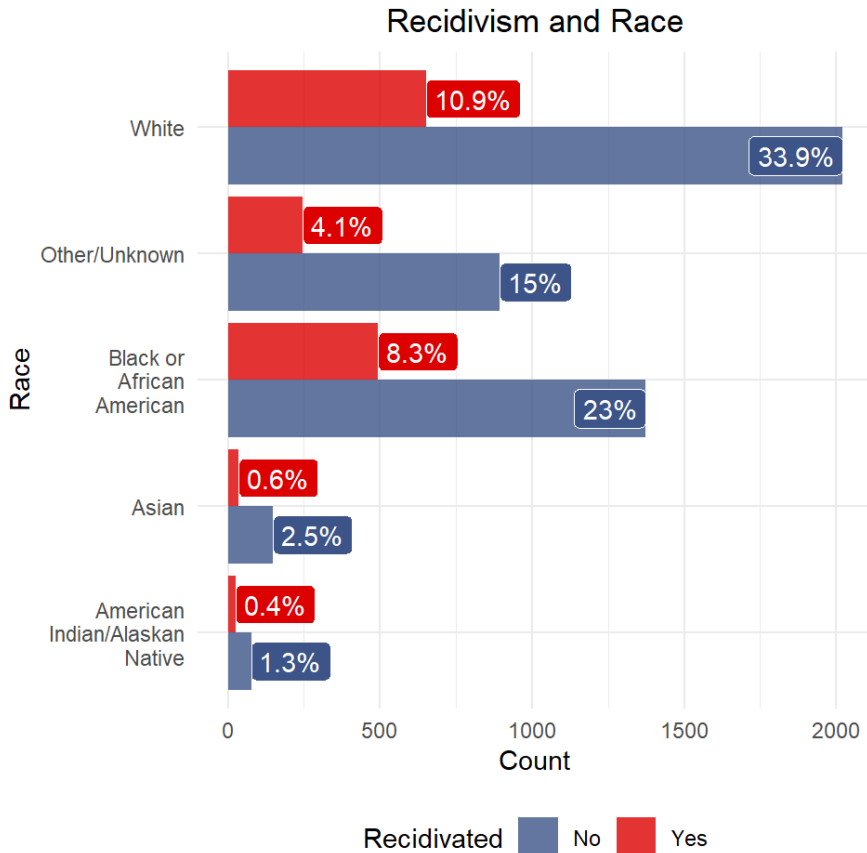

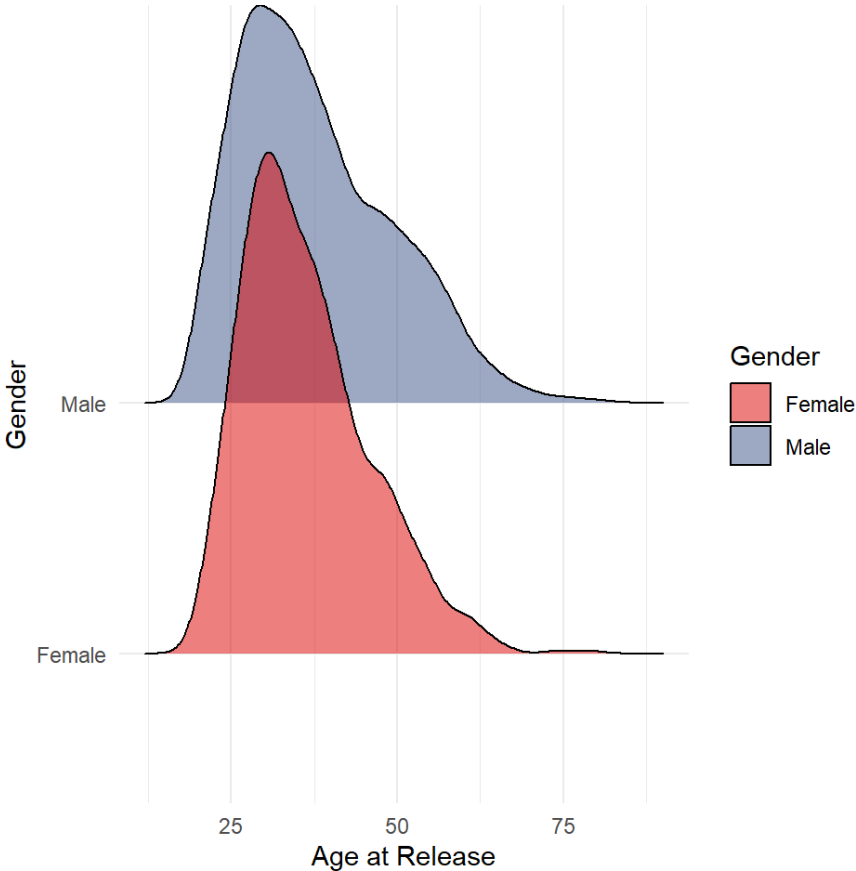

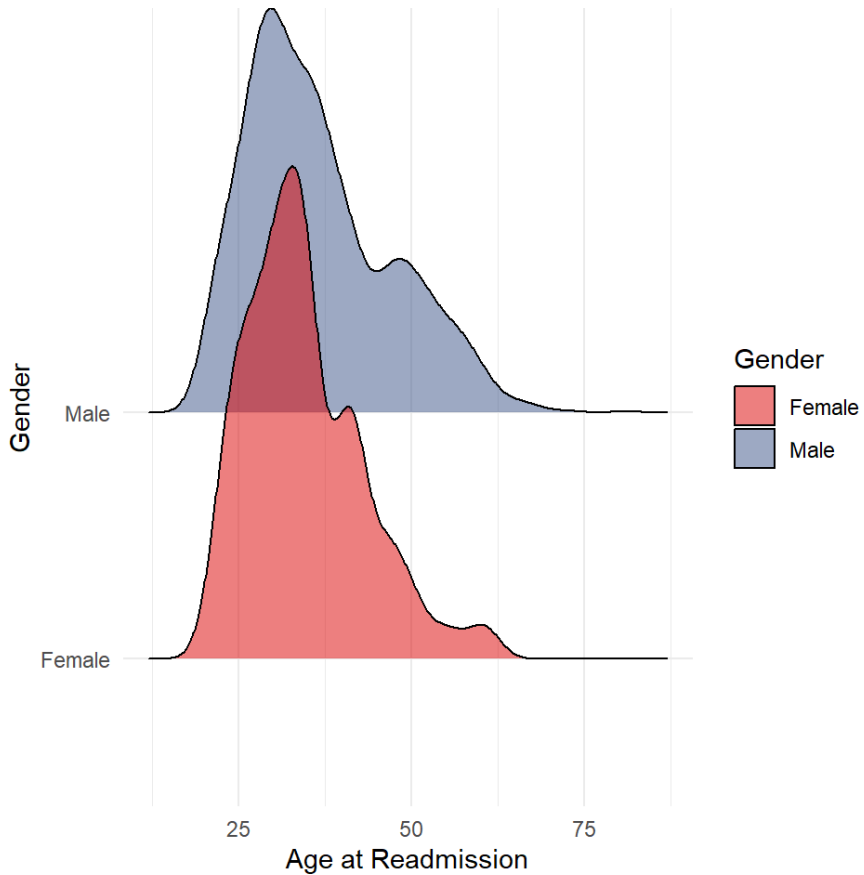

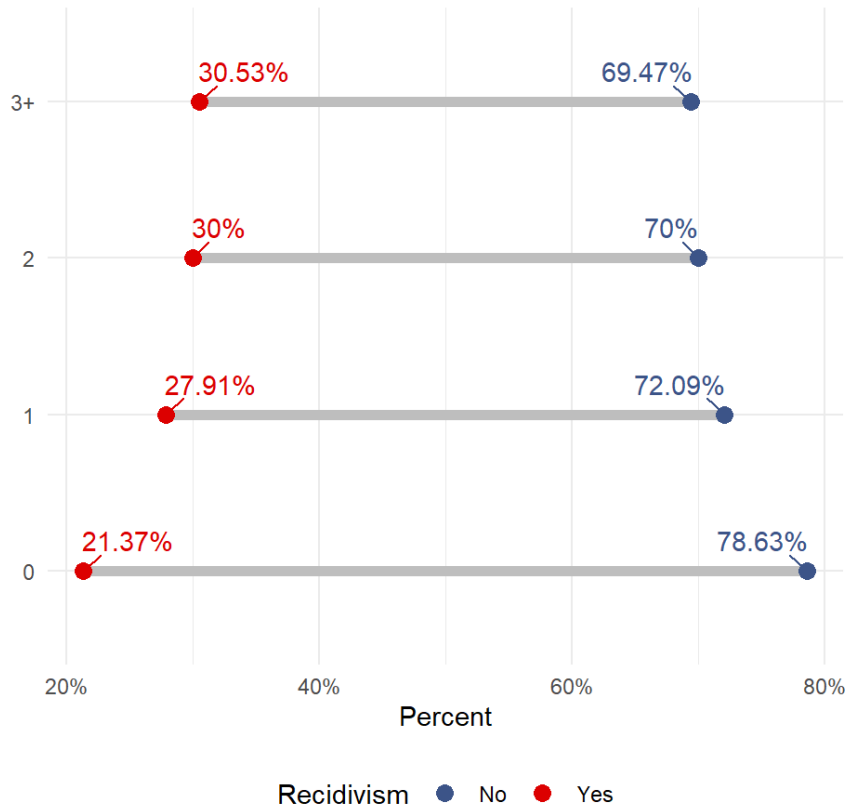

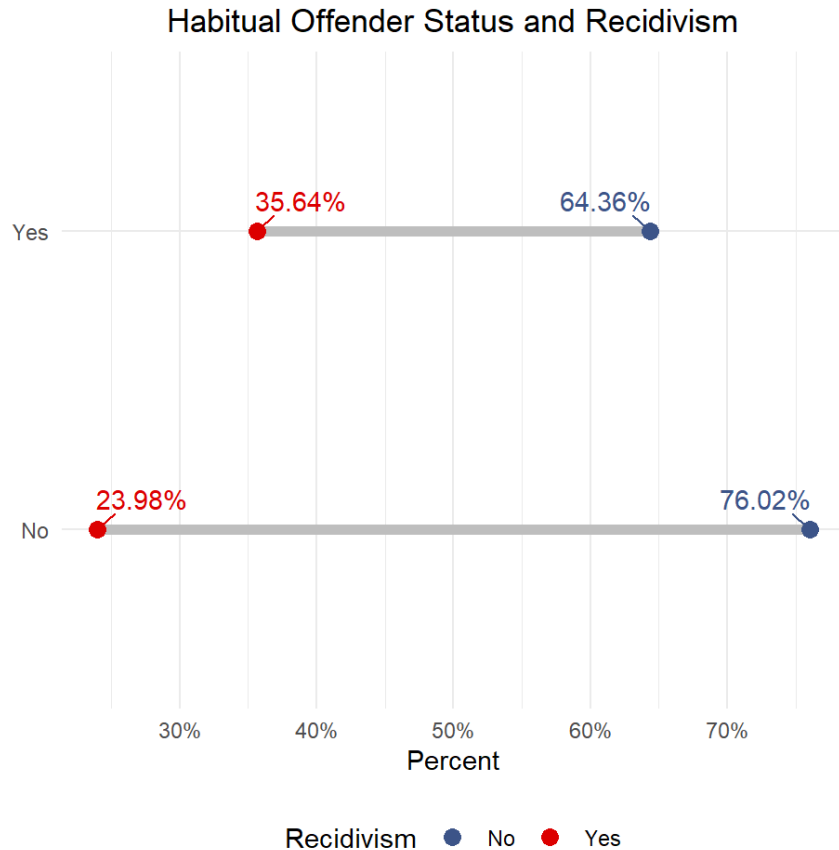

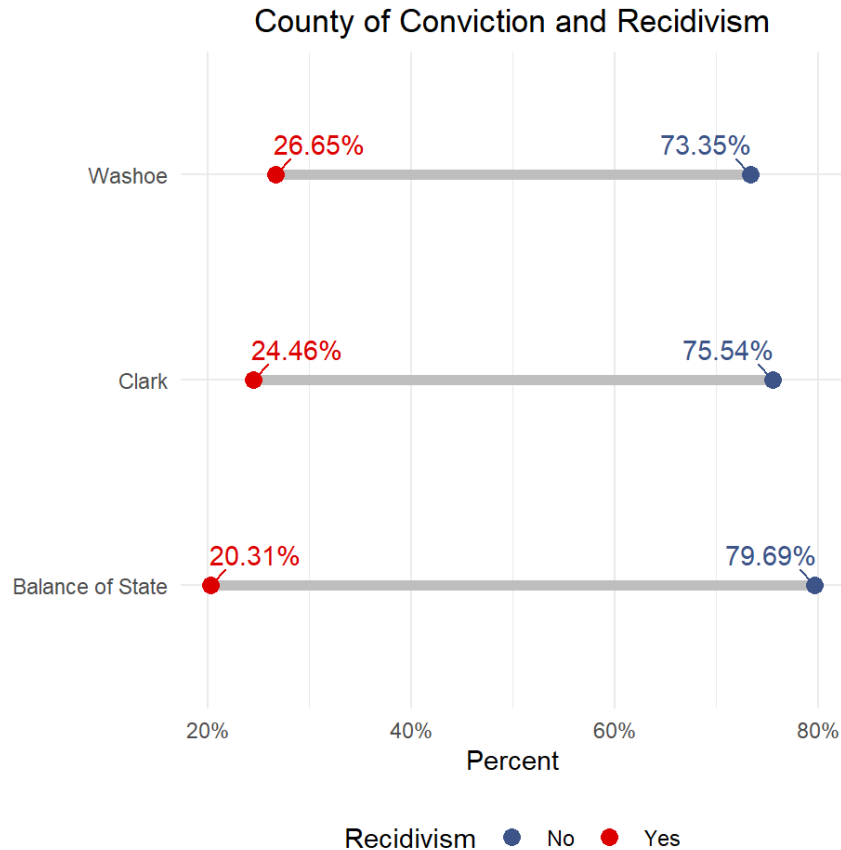

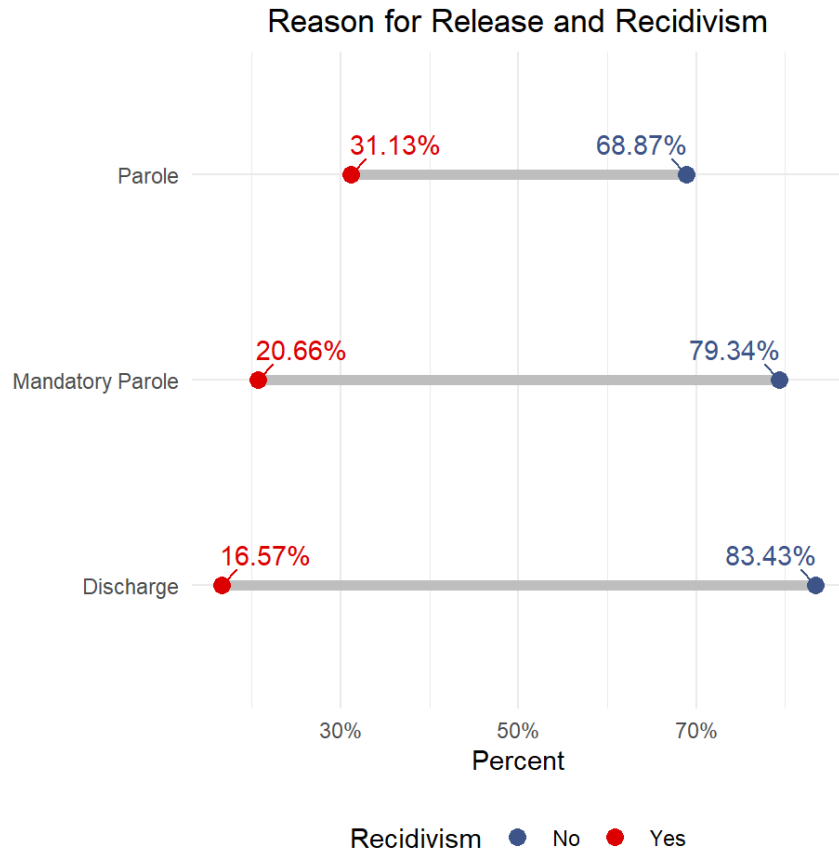

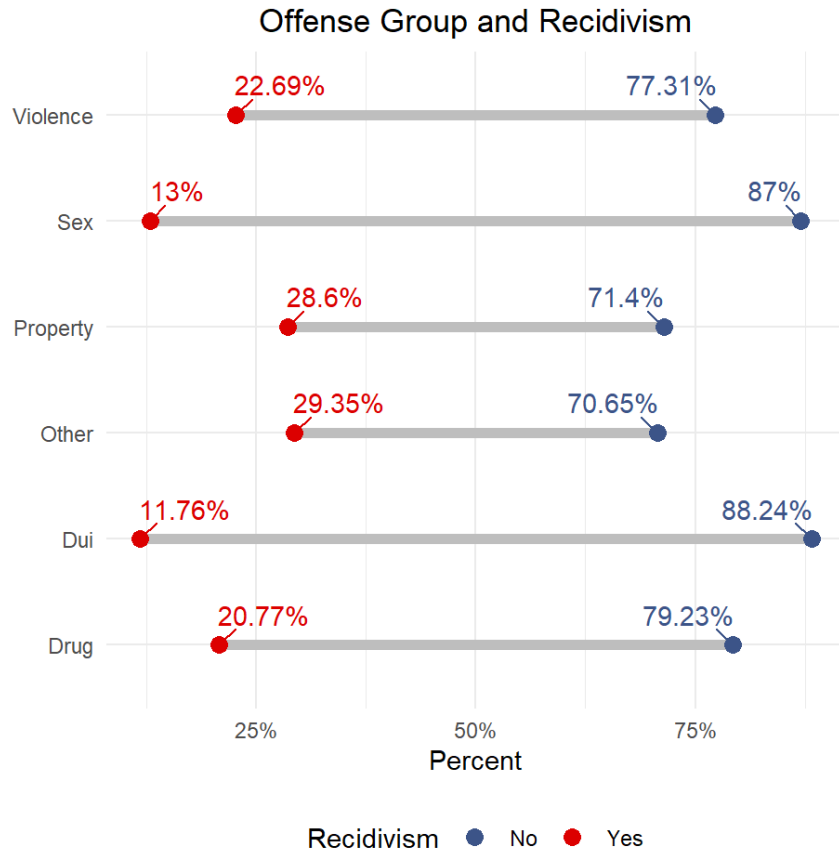

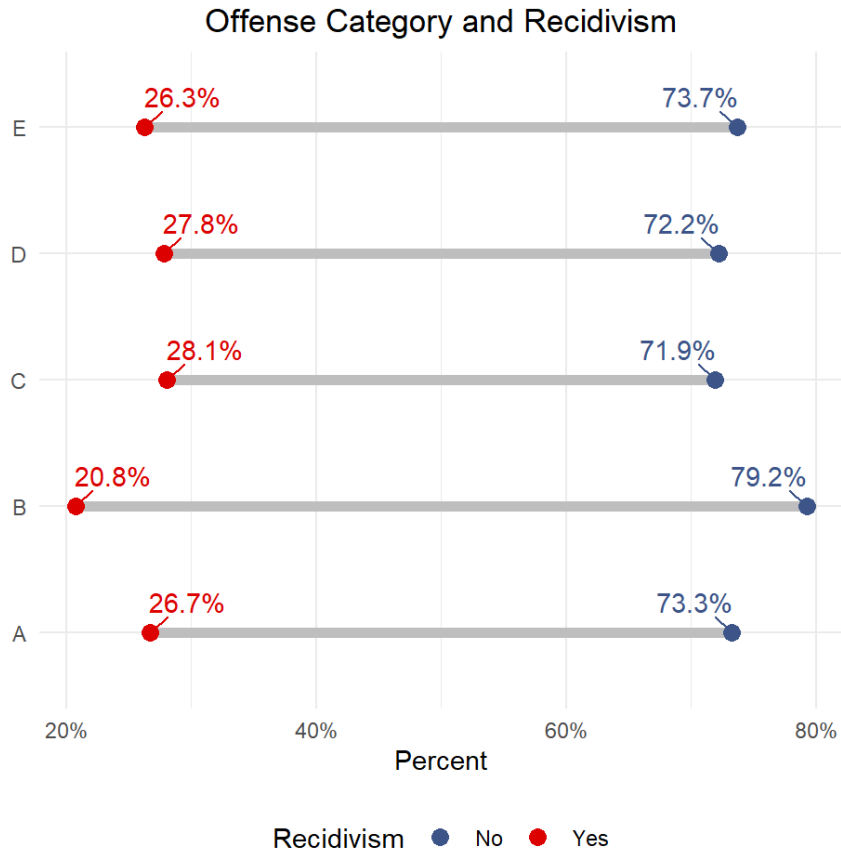

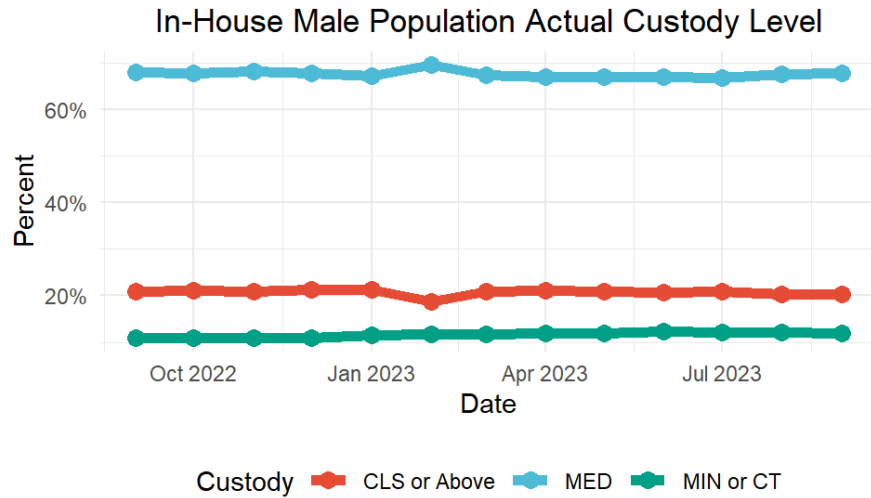

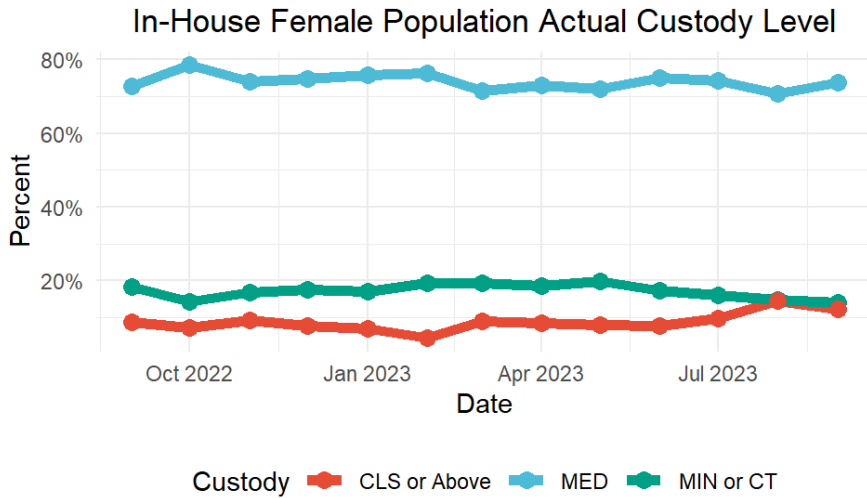

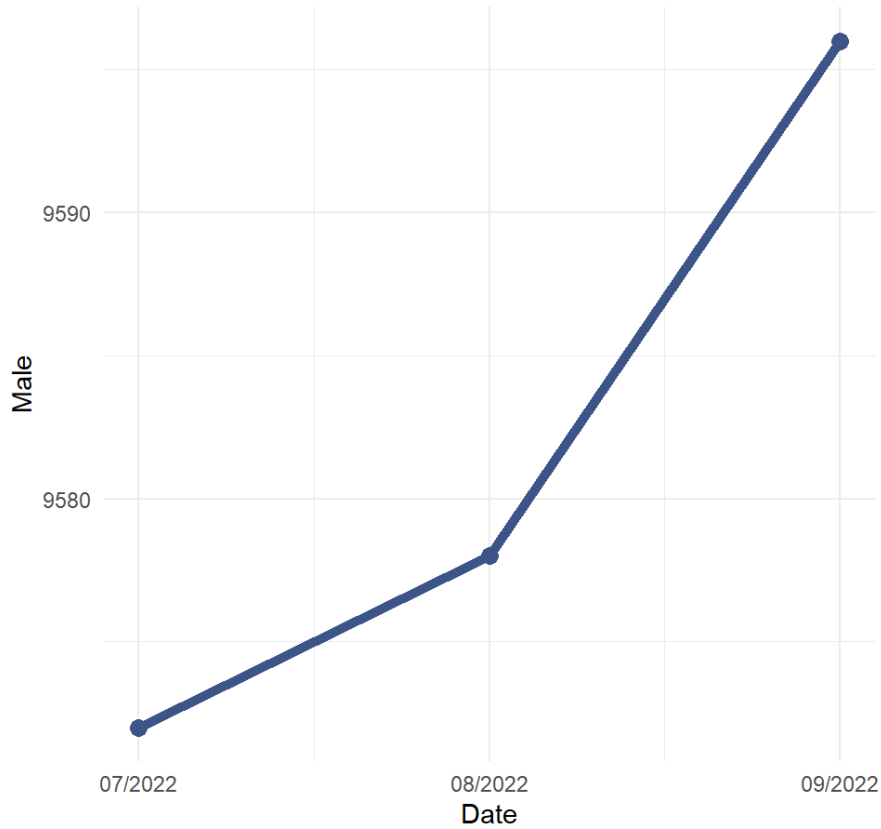

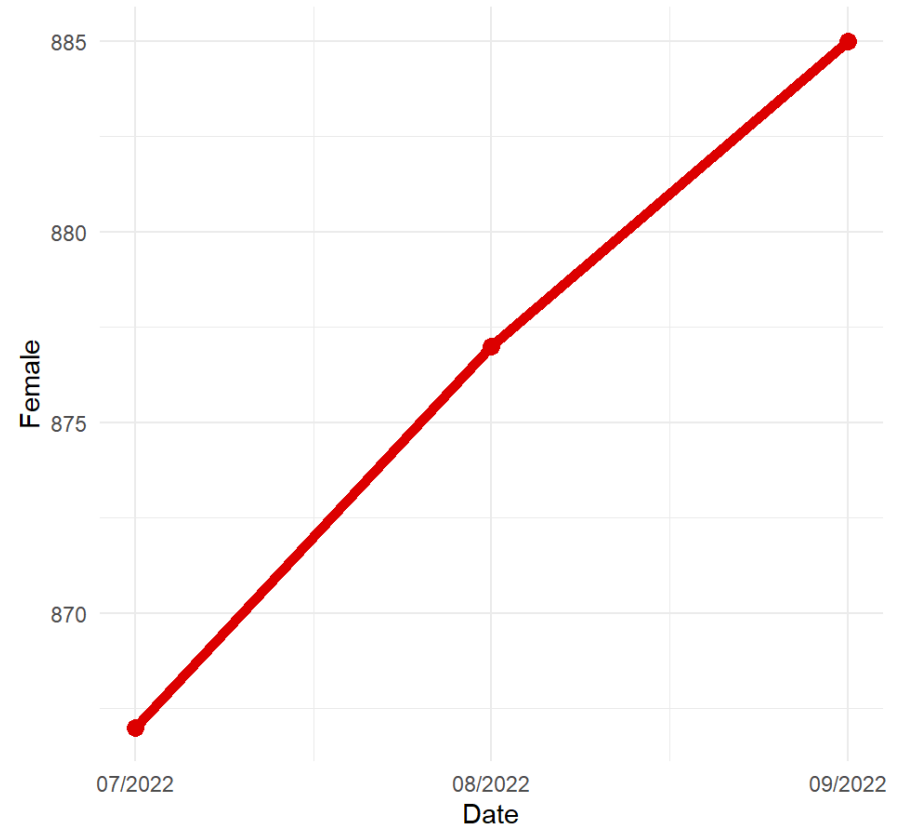


Total Correctional Population

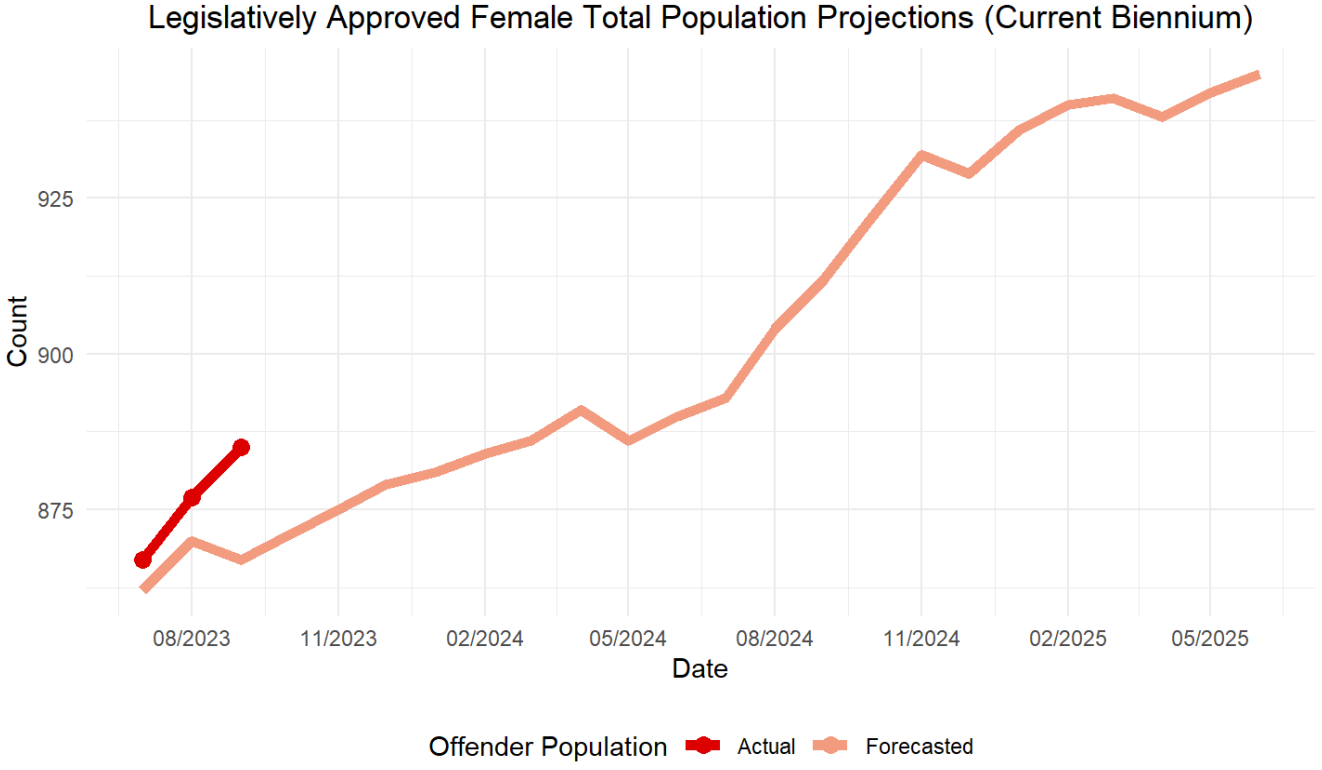

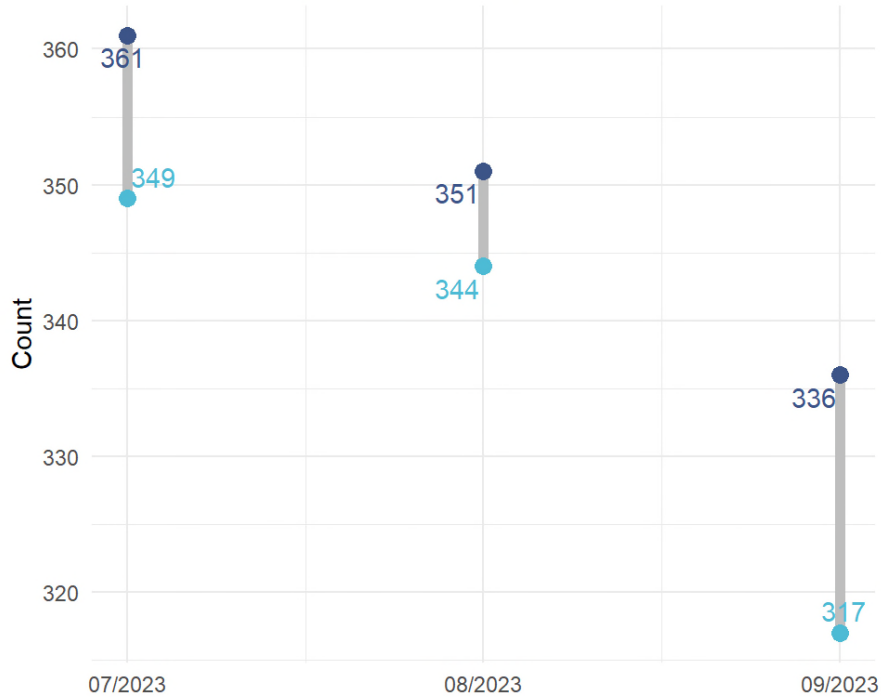

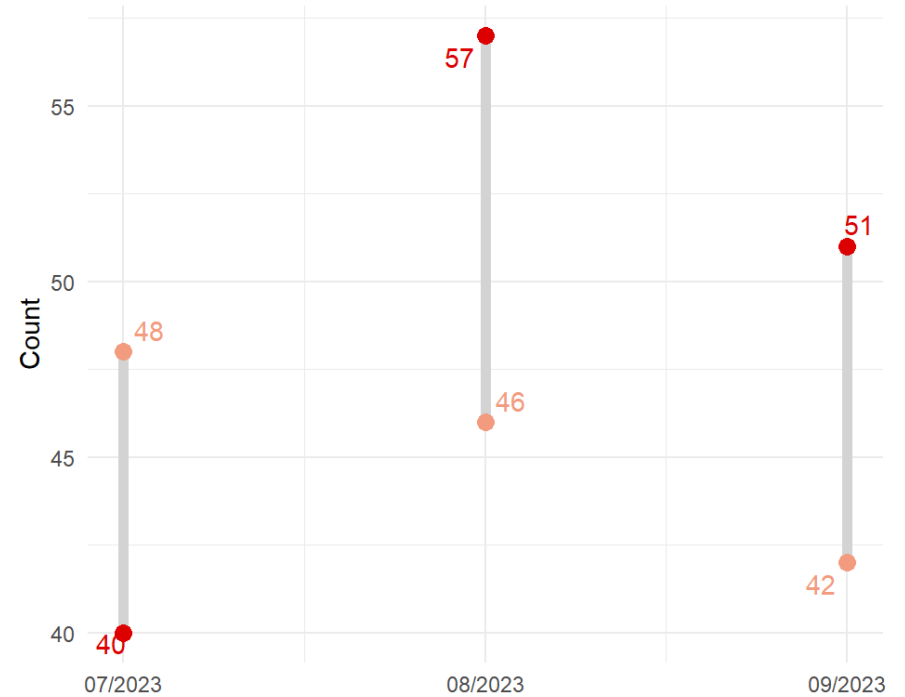

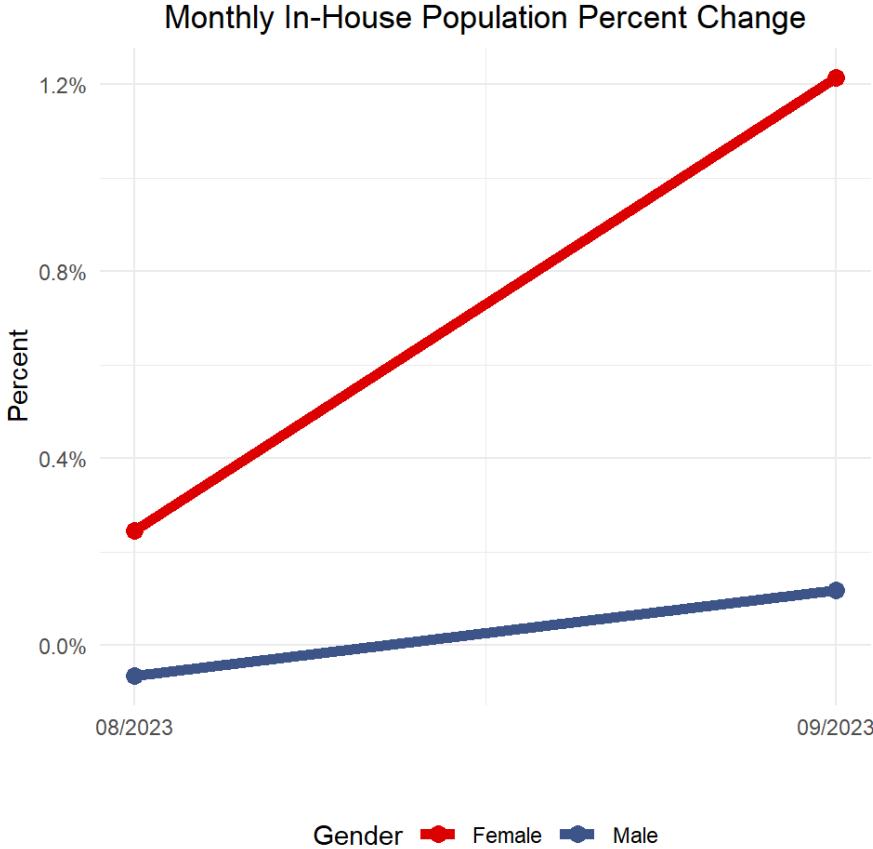

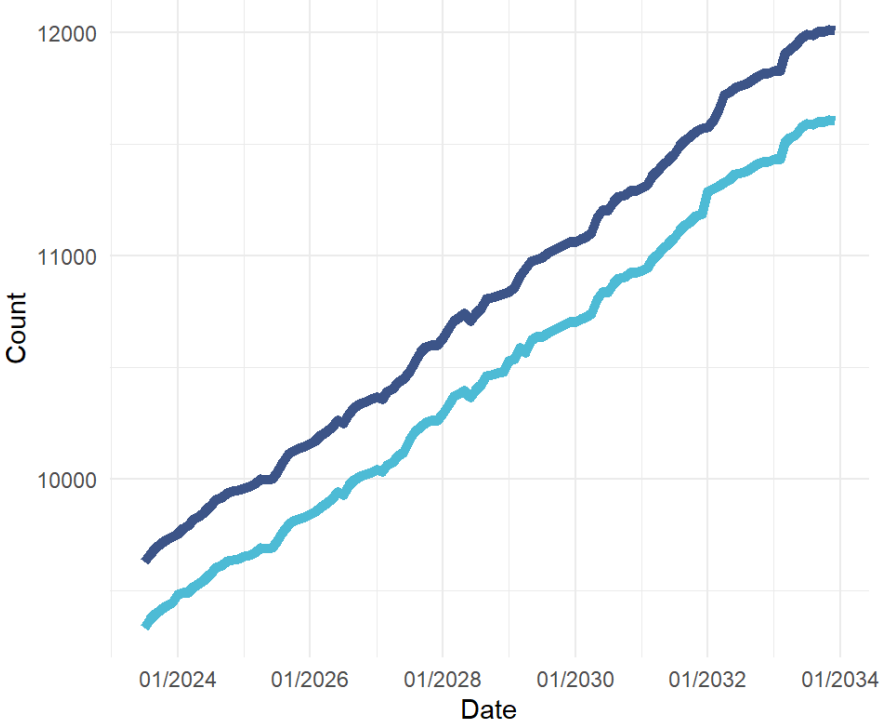

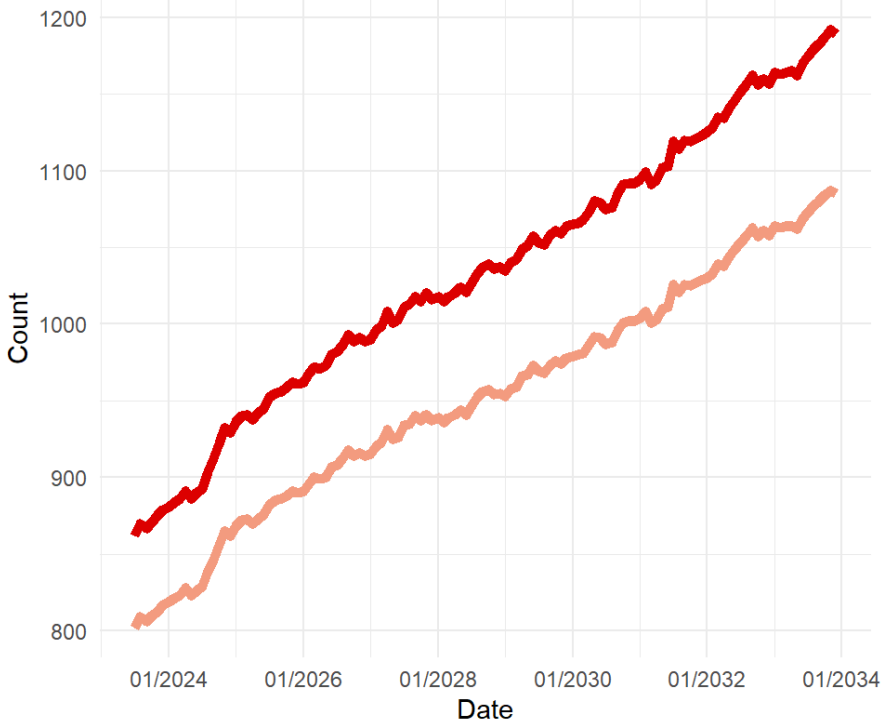

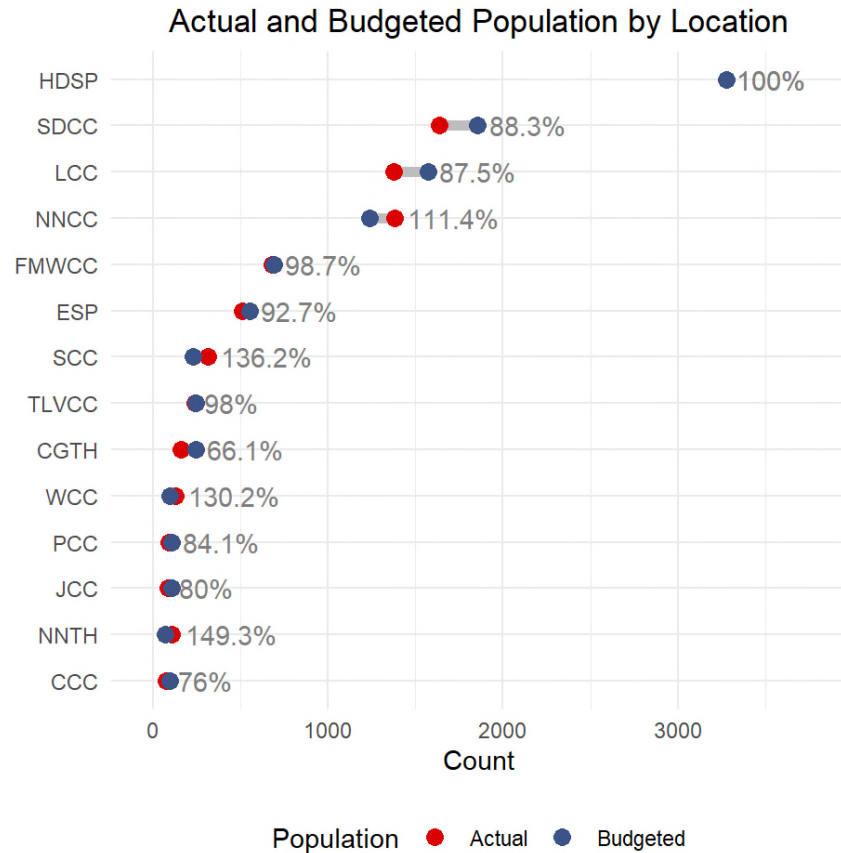

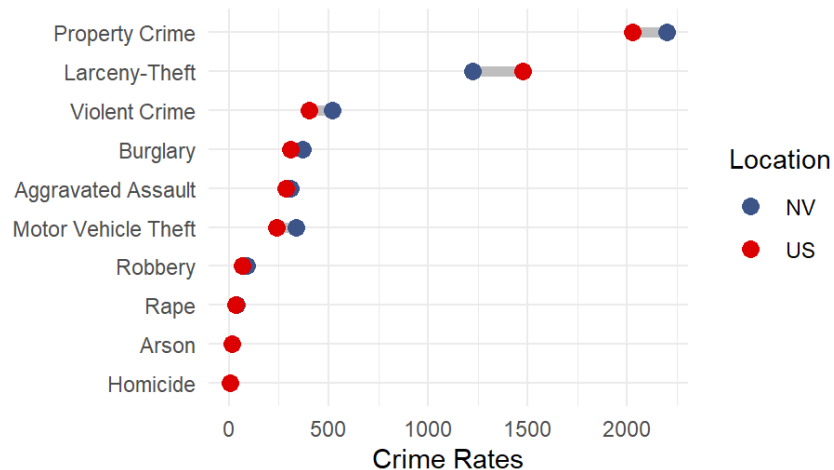

Unemployment Rate in Nevada by Quarter

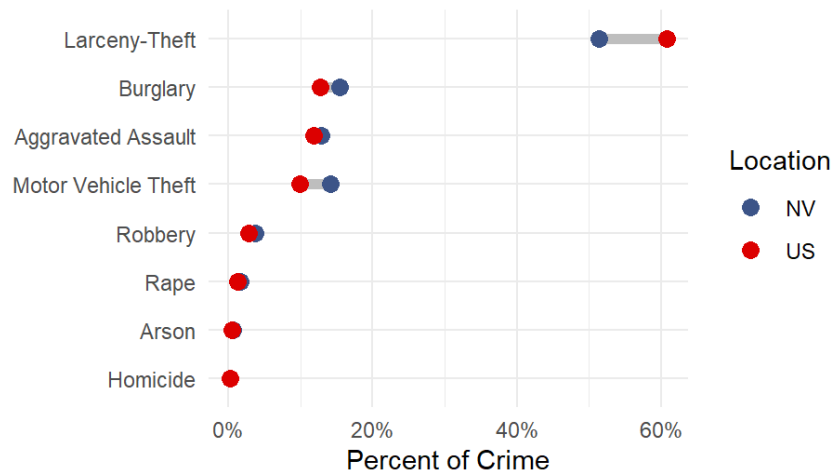

Data Limitations/Notes

- Data published in this report were extracted from a live database; thus, it is possible that figures reported in tables and charts do not balance to totals reported in other reports published by the Nevada Department of Corrections (NDOC). Select distributions consist of estimates and are susceptible to rounding error and missing data that could have caused these distributions not to add up to exactly 100%. Current fiscal year data for the NDOC or for other agencies are not always available at time of edition.
- Unless specified, figures in this report are retrieved from the Nevada Department of Corrections InfoView data warehouse, from the Nevada Department of Corrections Offender Tracking System (NOTIS), or from internal NDOC reports.

- Unless otherwise noted, all figures in the Demographics and Criminality sections are derived from the total offender population, which includes all offenders under NDOC jurisdiction.
- All figures in the Recidivism section are derived from the release cohort. This excludes offenders who were released from non-correctional facilities, were released from other jurisdictions, or were held by NDOC for other jurisdictions. Recidivism is defined by NDOC as re-incarceration within 3 years of release. This figure is not adjusted for deaths after release.
- [1]: These figures are derived from in-house population totals, which include offenders held in NDOC institutions and facilities. NDOC has been gradually converting its offender population racial group categories pursuant to the the U.S. Office of Management and Budget 1997 Standards for the Classification of Federal Data on Race and Ethnicity.
