However, the cost of housing these individuals was an additional operating expense added to the FY 2019 budget and this cost is not reflected in the figures above. Beds are rented on a temporary basis to reduce overcrowding and improve programming efficiency. On August 20, 2018, this figure was adjusted upwards with the correct number of individuals on escape status
