We are here as a benefit and to bring our services to help the Nevada Department of Corrections inmates that fall into relapse each year. This is with the permission for a trial basis for our program to be used from Mr. Howard Skolnik, Director of NDOC. This is our update to you.

I have in front of me a (402) page report from the grant firm I contracted called a GRO report. No, I will not be issuing this for you all to read!! DVDs/Brochures,yes!

Within the first 10-20 pages, it outlines well over the amount of Federal funding we are applying for from many different departments of our Government under substance abuse/treatment grants as well as private foundations. SAPTA/SAMSHA, it's all in here.

We are applying for two grants in the amount of 2.5 million

each.

The first one is for a (5) year program and our operational support at 2.5 million dollars and spread out over five years.

The second one is for 2.5 million in treatment dollars alone provided for all the low to moderate income families/individuals that can not otherwise afford treatment. I will also go to bat for getting the overall cost of treatment lowered.

LL Bradford & Company CPA firm in Las Vegas area will handle the accounting for us and the Bank of the West here in Carson City will handle this account. Kafoury & Armstrong CPA, Andree Rose, is finalizing our 501-C3 certification now and the "Community Reinvestment Act" here in Carson City has a small donation of 5,000.00 being considered now to be made to us to enable us to file the 501-C3 and finish hiring the grant writing firm.

We are in need of donations in any amount from any source to help sustain us until Federal funding does arrive.

I brought some much valued help and support here today to introduce you all to.

I am proud to introduce to you all our new Executive Director to the "I AM" Workshop Tour that brings many years of experience to us in nonprofit work and substance abuse work to our table, Mr. John Shields. Applause!

Next, I bring you a man with over (30) years experience in Public Broadcast work, also in charge of our entire

production department/DVD presentations almost completed now for Mr. Skolnik, Mr. Gary Ashby of GALA Productions. Applause!

We absolutely have a winning team now and program that will help a whole lot of lives here in this State with disease control, which as you all know addiction is, nutritional programs and counseling programs too even via our website.

The treatment program we are advocate for in Los Angeles will be in full support for us, (DVDs) etc.. as well as in financial support, just as soon as we prove ourselves to them too.
