## CRIME VICTIMS RIGHTS

The Nevada Constitution and Nevada Revised Statute 209.521 provide for certain rights to victims of crime. The Nevada Department of Corrections (NDOC), upon the written request of a victim, must provide notification to victims regarding an offender's status.

## WHO IS A VICTIM?

An individual who suffers direct or threatened physical, financial or emotional harm as a result of the commission of a crime is considered a "victim". Other persons such as the spouse, child, parent, sibling, grandparent or guardian may also qualify as a victim if the victim is deceased or is physically unable to exercise the privileges and rights of the victim.

## WILL MY INFORMATION BE KEPT CONFIDENTIAL?

**Yes.** Victim names, addresses and phone numbers are confidential pursuant to Nevada Revised Statute 209.521.

## IMPORTANT INFORMATION TO NOTE

Registration with the Department of Corrections is not automatic. In order to be registered to receive notifications, a victim or victim's family member must contact the Department of Corrections and request to be registered.

**Registration in VINE does not automatically register you with the Department of Corrections.**

## HOW DO I REQUEST TO BE NOTIFIED?

You may request notification by completing an NDOC Victim Notification Request Form. This form is available from the prosecuting attorney, from victim service advocates in your community, or it can be downloaded from the victims' link on the NDOC website at: [www.doc.nv.gov](http://www.doc.nv.gov). In addition, you can request a form by e-mailing [victiminfo@doc.nv.gov](mailto:victiminfo@doc.nv.gov).

## TYPES OF NOTIFICATIONS:

The Victim Services Unit will provide written notification about the following:

- Earliest parole eligibility date
- Location of the offender
- Release of the offender to a residential confinement program.
- Discharge date of the offender.
- Escape of the offender.
- Current photograph of the offender upon release from the Department of Corrections' custody can be obtained upon request.

## **Nevada VINE**

Nevada VINE [Victim Information Notification Everyday] is a free, confidential, 24-hour service that provides victims of crime and members of the community two important services:

### **INFORMATION**

Nevada VINE will provide the caller with inmate custody status and location information.

### **NOTIFICATION**

Callers have the option to register to receive automated telephone or email notification if there is a change in an inmate's custody status.
