### **Purpose**

The Prison Rape Elimination Act (PREA) requires that an agency collect and review data in order to assess and improve the effectiveness of its sexual abuse prevention, detections, and response policies, practices, and training. The data collected should include identifying problem areas, identifying the ongoing corrective action taken by the agency, and each of its institutions.

#### In conjunction with PREA standard §115.88:

Substandard (a)(3), the agency shall, "...preparing an annual report of its findings and corrective actions for each facility, as well as the agency as a whole."

(a)(3)(b) "Such report shall include a comparison of the current year's data and corrective actions with those from prior years and shall provide an assessment of the agency's in addressing sexual abuse."

(a)(3)(c) "The agency's report shall be approved by the agency head and made readily available to the public through its website..."

This report is intended to provide information and comparison for calendar years 2014, 2015, 2016, 2017, 2018, 2019, and 2020.

#### Introduction

The State of Nevada is committed to preventing, detecting, and responding to sexual abuse and sexual harassment in confinement. The Nevada Department of Corrections (NDOC or agency) has a zero-tolerance policy for sexual abuse and sexual harassment in all its confinement facilities. The report is an overview of agency and facility aggregated data, and corrective action as it pertains to the Prison Rape Elimination Act.

# **Background**

The Prison Rape Elimination Act (PREA) was signed into Federal law in September 2003. The purpose of the Act was to "provide for the analysis of the incidence and effects of prison rape in Federal, State, and local institutions and to provide information, resources, and recommendations to protect individuals from prison rape. PREA, also, mandated the publication of standards to ensure compliance and improve detection and response strategies in addressing sexual abuse and assault.

The final rule for PREA was published in the Federal Register on June 20, 2012, and became effective August 20, 2012. Facilities had one year to become compliant with PREA standards.

The PREA standards require annual audits of one-third of the facilities under an agency's jurisdiction along with the Governor's certification of statewide compliance in all facilities under the operational control of the state's executive branch, including private facilities operated on behalf of the executive branch to house inmates. A failure to comply with standards will result in a loss of 5 percent (5%) of identified Federal grant funding.

#### **Governor Certification**

Each Governor is required to annually certify statewide PREA compliance for all applicable "...facilities in the State under the operational control of the State's Executive branch, including Facilities operated by private entities on behalf of the State's Executive branch. (Standard 115.501).

Three options are provided to Governors:

- Certification that the state and all applicable facilities are in full compliance with the National Standards to Prevent, Detect, and Respond to Prison Rape, 28 C.F.R. Part 115;
- Assurance that the state/jurisdiction will use not less than 5 percent (5%) of grant funds as identified by the Department of Justice to enable the state/jurisdiction to adopt and achieve full compliance with the National Standards to Prevent, Detect, and Respond to Prison Rape, 28 C.F.R. Part 115; or
- Decisions on the part of the Governor not to certify compliance or provide an assurance that the state/jurisdiction is moving toward compliance.

#### **Definitions**

#### **Case Dispositions**

Substantiated: An allegation that was investigated and determined to have occurred.

Unsubstantiated/Not Sustained: An allegation that was investigated and produced insufficient evidence to make a final determination as to whether the event occurred.

Unfounded: An allegation that was investigated and determined to not have occurred.

#### Sexual Abuse

#### **Inmate-Inmate Sexual Abuse:**

Sexual abuse of an inmate by another inmate includes any of the following acts, if the victim does not consent, is coerced into such act by overt or implied threats of violence, or is unable to consent or refuse:

- 1. Contact between the penis and the vulva or the penis and the anus, including penetration, however slight;
- 2. Contact between the mouth and the penis, vulva, or anus;
- 3. Penetration of the anal or genital opening of another person, however slight, by a hand, finger, object, or other instrument; and
- 4. Any other intentional touching, either directly or through the clothing, of the genitalia, anus, groin, breast, inner thigh, or the buttocks of another person, excluding contact incidental to a physical altercation.

#### Staff, Contractor, or Volunteer on Inmate Sexual Abuse:

Sexual abuse of an inmate, detainee, or resident by a staff member, contractor, or volunteer includes any of the following acts, with or without consent of the inmate.

- 1. Contact between the penis and the vulva or the penis and the anus, including penetration, however slight; Contact between the mouth and the penis, vulva, or anus;
- 2. Contact between the mouth and any body part where the staff member, contractor, or volunteer has the intent to abuse, arouse, or gratify sexual desire;
- 3. Penetration of the anal or genital opening, however slight, by a hand, finger, object, or other instrument, that is unrelated to official duties or where the staff member, contractor, or volunteer has the intent to abuse, arouse, or gratify sexual desire;
- 4. Any other intentional contact, either directly or through the clothing, of or with the genitalia, anus, groin, breast, inner thigh, or the buttocks, that is unrelated to official duties;

- 5. Where the staff member, contractor, or volunteer has the intent to abuse, arouse, or gratify sexual desire;
- 6. Any attempt, threat, or request by a staff member, contractor, or volunteer to engage in the activities described in paragraphs A-E of this section;
- 7. Any display by a staff member, contractor, or volunteer of his or her uncovered genitalia, buttocks, or breast in the presence of an Inmate; and
- 8. Voyeurism by a staff member, contractor, or volunteer.

**Voyeurism:** Voyeurism by a staff member, contractor, or volunteer means an invasion of privacy of an inmate, detainee, or resident by staff for reasons **unrelated to official duties**, such as peering at an inmate who is using a toilet in his or her cell to perform bodily functions; requiring an inmate to expose his or her buttocks, genitals, or breasts; or taking images of all or part of an inmate's naked body or an inmate performing bodily functions.

# **Progress in Addressing Sexual Abuse**

The Nevada Department of Corrections (NDOC) has supported PREA and has been working towards compliance since 2012. To date, all NDOC facilities have completed PREA audits with all state facilities successfully passing PREA National audits. As the agency moves forward and continues to evolve, we began PREA audit cycle 3 in August 2019. Six facilities received their 3rd national PREA audit during the calendar year 2020. Five received full compliance during PREA audit year one of cycle three, beginning August 20, 2019 – August 19, 2020, and one received full compliance in audit year two of cycle three, beginning August 20, 2020.

# 2020 Agency Achievements

NDOC has accomplished the following regarding PREA prevention, detection, and response strategies:

- Before COVID-19 pandemic restrictions, the agency regularly trained new employees, pre-service staff, volunteers, and health care service staff. Essential staff and contractor training continued with limited contact.
- Continued partnership with the Western State Audit Consortium.
- Successfully completed six PREA audits.
- Agency PREA coordinator and DOJ Certified PREA auditor conducted two out-of-state facilities PREA audits as part of a circular auditing consortium with the western states.
- During COVID-19, the agency PREA Coordinator emailed ongoing information and updates to facility PREA Compliance Managers.
- Updated coordinated response procedures.
- PREA Coordinator developed inmate investigation outcome notification form.
- PREA Coordinator revised and enhanced facility sexual abuse incident review committee form.





#### **Carlin Conservation Camp**

The Carlin Conservation Camp houses 150 minimum-custody inmates for the State of Nevada. Inmates at the Carlin Conservation Camp work for the Nevada Division of Forestry completing conservation projects, roadside cleanup, local area assistance, and firefighting during the fire season. During the off-fire season, these crews assist with community cleanup and snow removal services. Carlin Conservation Camp offers High School Equivalency and Firefighting Basic Training.



### Casa Grande Transitional Housing Center

The Casa Grande Transitional Housing (Casa Grande) center has been operating since December 2005. The dormitory-style facility was built to house non-violent, non-sex crime inmates who are within 18 months of their parole eligibility date. The main purpose of Casa Grande was, and still is, to allow these "residents" the opportunity to seek work and secure permanent housing prior to reintegrating into society. The facility had an average population of 130 male and 46 female "residents" and offers many programs and community partnerships.



#### **Ely Conservation Camp**

Ely Conservation Camp (ECC) was constructed in 1984. The camp is located approximately 17 miles south of Ely on Horse and Cattle Camp Road. Due to the COVID-19 pandemic, ECC was temporarily closed from July 2020 to the end of 2020. Before the closing of the camp, they housed minimum-security inmates and had an average population of 72 Inmates.




#### **Ely State Prison**

Ely State Prison opened in July 1989 and is the designated maximum-security prison for the State of Nevada. The facility is located approximately 9 miles north of Ely in White Pine County. The facility had an average population of 711 inmates during this timeframe. Inmates are offered vocational training, educational opportunities, and treatment services.



#### Florence McClure Women's Correctional Center

The Florence McClure Women's Correctional Center opened in September 1997. On October 1, 2004, the Nevada Department of Corrections assumed control of the institution. The facility had an average population of 782 inmates during this timeframe. The Florence McClure Women's Correctional Center offers a wide range of programs for all of the inmate population, which include, but are not limited to Anger & Aggression; Clark County Parenting; Commitment to Change I, II & III; Employment Skills; Healthy Steps to Freedom; Seeking Safety I, II & III; Sex Inmates Treatment Program; Straight Ahead; Survivors Overcoming Abuse and Rape; Thinking for a Change; and Turning Point and Victim Impact. The Toastmasters Program and Alcoholics Anonymous are, also, available.



#### **High Desert State Prison**

The High Desert State Prison is the largest major institution in the Department of Corrections. It is the first institution in what will become a large Southern Nevada prison complex. High Desert State Prison was designed to incorporate much of the best technology available in Corrections to provide for officer safety and the management and control of inmates. The complex totals approximately 1,576,000 square feet of space. The institution opened September 1, 2000, and became the new reception center for Southern Nevada. The facility had an average population of 3,408 inmates during this timeframe.



#### **Humboldt Conservation Camp**

Located in Humboldt County, Humboldt Conservation Camp officially opened in 1986 and consists of 22 trailers brought down from the Alaskan pipeline project. Humboldt Conservation Camp is a Nevada Division of Forestry fire camp and can have as many as six 12-man crews fighting fires at any given time. During the off-time of firefighting, the crews spend their days doing project work, such as highway cleanup for the Department of Transportation or working in the local community.



#### Jean Conservation Camp

Located in Jean, Nevada, the Jean Conservation Camp was constructed in 1988 and houses 240 minimum-custody female inmates for the State of Nevada. Currently, Jean Conservation Camp is the only camp within Nevada that houses female inmates with an average population of 83 inmates during this timeframe. Inmates at the Jean Conservation Camp work for the Nevada Division of Forestry by fighting fires during the fire season, completing conservation projects, performing highway cleanup for the Department of Transportation, and assisting with the local community.



#### **Lovelock Correctional Center**

Located in Pershing County, Lovelock Correctional Center, the Department's seventh major institution, was constructed and opened in two phases. The first phase opened in August 1995, with two 168-cell housing units. Each 80-square-foot cell can house 2 inmates. Construction on phase two began shortly after, and two additional 168-cell units and two 84-cell units were added to the institution, bringing the budgeted capacity to 1,680 inmates. Lovelock houses mediumcustody general population inmates, youthful inmates, close-custody protective segregation inmates, along with a separate unit housing a small number of minimum-custody inmates. The total capacity for Lovelock Correctional Center is approximately 1,680 inmates.



#### Northern Nevada Correctional Center

Northern Nevada Correctional Center (NNCC) opened in 1964, with three housing units. From that date until 2008, seven additional housing units were added. NNCC is a medium-custody facility. NNCC is the Intake Center for the Northern region. The Regional Medical Facility for Nevada is located here. This includes an in-patient medical and mental health unit. In addition, there is the Medical Intermediate Care and Structured Care Unit for those inmates whose medical and mental health situations are stable but require additional staff monitoring.



#### **Northern Nevada Transitional Housing**

Northern Nevada Transitional Housing houses up to 103 male inmates who are classified as nonviolent and non-sex inmates and within one year of term expiration or parole eligibility. Through this program, the inmates are given the opportunity to establish employment in the community to better prepare them for release, as well as address court-ordered fees, fines, and restitution obligations.



#### **Pioche Conservation Camp**

Established in 1980, the Pioche Conservation Camp (PCC) was the first conservation camp established by the Nevada Department of Corrections in rural Nevada. It provides Initial Attack Wildland Firefighting Crews operated by the Nevada Division of Forestry for Lincoln County and the State of Nevada. PCC houses 196 male Inmates in dormitory-style living arrangements, with the capability to house up to 238 male Inmates during times of need in the Department.



#### **Southern Desert Correctional Center**

Southern Desert Correctional Center (SDCC) houses mostly medium-custody general population inmates, along with two separate specialized programming units. The total capacity for SDCC is approximately 2,149 inmates. SDCC offers a wide range of programs for the inmate population and an opportunity to pursue a high school diploma, GED, or a college degree. SDCC offers the most programs of any of the NDOC facilities located in the State of Nevada.



#### **Stewart Conservation Camp**

The Stewart Conservation Camp (SCC) is located adjacent to the Northern Nevada Correctional Center. It originally opened in 1978. In 1995, a new SCC was constructed to replace and double the size of the original camp. SCC houses minimum-custody and community-trustee inmates in five dormitory-type units. Most of the inmates at SCC work for the Nevada Division of Forestry and are assigned to 12-man fire crews. Also, inmates work for Silver State Industries, which runs the ranch, dairy, and the Wild Horse Training Program. Some of the inmates are classified as community trustees who provide support services for several state agencies in Carson City, Nevada.



The Three Lakes Valley Conservation Camp (TLVCC) houses only minimum custody and Work Release inmates. The capacity for TLVCC is 192. TLVCC supplies inmates to the Nevada Division of Forestry for work projects that include roadside litter removal, landscape beautification, and fighting wildfires.



The Tonopah Conservation (TCC) opened its doors in January 1991, as a female facility. It's located approximately 12-miles northeast of the historic mining town of Tonopah, Nevada. TCC was converted to an all-male facility in September 1991. TCC is currently a camp dedicated to fire suppression with guidance from the Nevada Division of Forestry.



#### **Warm Springs Correctional Center**

The Warm Springs Correctional Center (WSCC) was authorized by, and constructed through, appropriations from the 1961 Legislative Session and was known as the Nevada Women's Correctional Center until September 1997. It was converted to a medium-security men's prison in 1998, then to a minimum-custody facility in July 2003. The institution has been remodeled and expanded four times over the past 47 years. A second housing unit was added in 1979, and a third in 1987. The core services building, which houses food services, health care services, education facilities, and the gymnasium, was added in 1981. The 1995 and 1997 Legislatures authorized a fourth housing unit, two towers, a new security fence, additional classrooms, and completely remodeled the kitchen, dining room, and entrance building. The completion of this project in July 1998 (funded in part with Federal monies) brought the budgeted capacity of WSCC from 260 to 510 inmates. In July 2008, WSCC was converted back to a men's mediumcustody institution.



#### Wells Conservation Camp

Wells Conservation Camp (WCC) is located at Exit 365 on Interstate 80 in Independence Valley. WCC houses minimum-custody inmates and operates under a cooperative partnership with the Nevada Division of Forestry. The Nevada Division of Forestry operates seven inmate work crews at WCC providing wildland firefighting support, as well as working on a variety of projects locally including, but not limited to, wildland conservation, community projects, senior citizen assistance, and highway beautification and cleanup projects with the Nevada Department of Transportation.
