Model Purpose

- 1) To create sufficient bed capacity to accommodate the JFA Associates February 2011 projection.
- 2) This plan closes NSP and reschedules the opening of Eagle's Nest from October 2012 to May 2014. Unit 7 at HDSP is opened during FY11. Units 5 & 8 at HDSP are re-opened in FY2012. In addition a long-term care modular for medium and close custody inmate is open.

Model Conditions & Assumptions

- 1) The in-house male prison population is expected to decrease by an average of .06% per fiscal year from the end of Fiscal Year 2010 through the end of Fiscal Year 2020.
- 2) The projected average outcount for the male population is 1.94% as of the end of Fiscal Year 2011 and this proportion is applied throughout the CIP.
- 3) The custody distribution was projected for the fourth quarter of Fiscal Year 2011 utilizing a moving average method.
