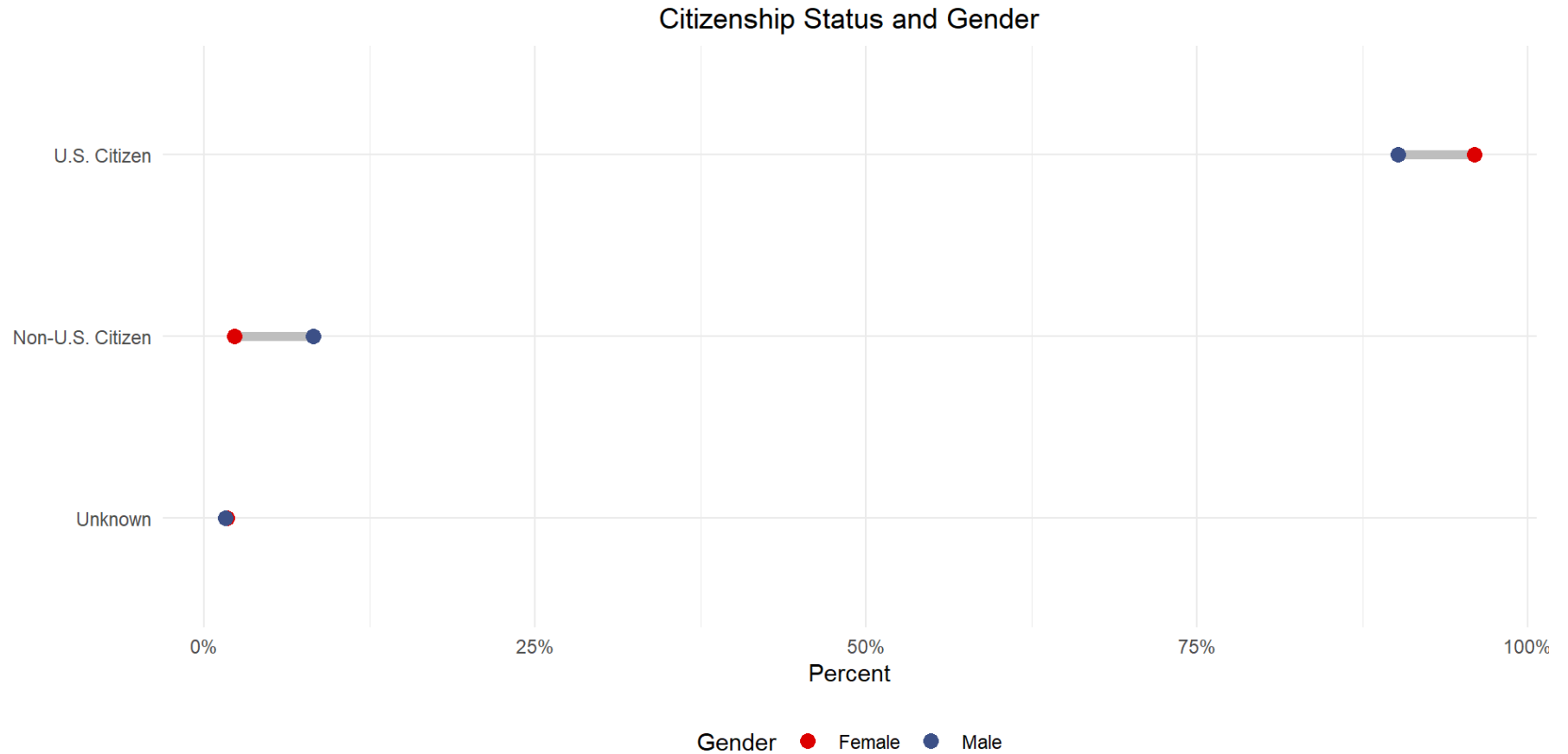

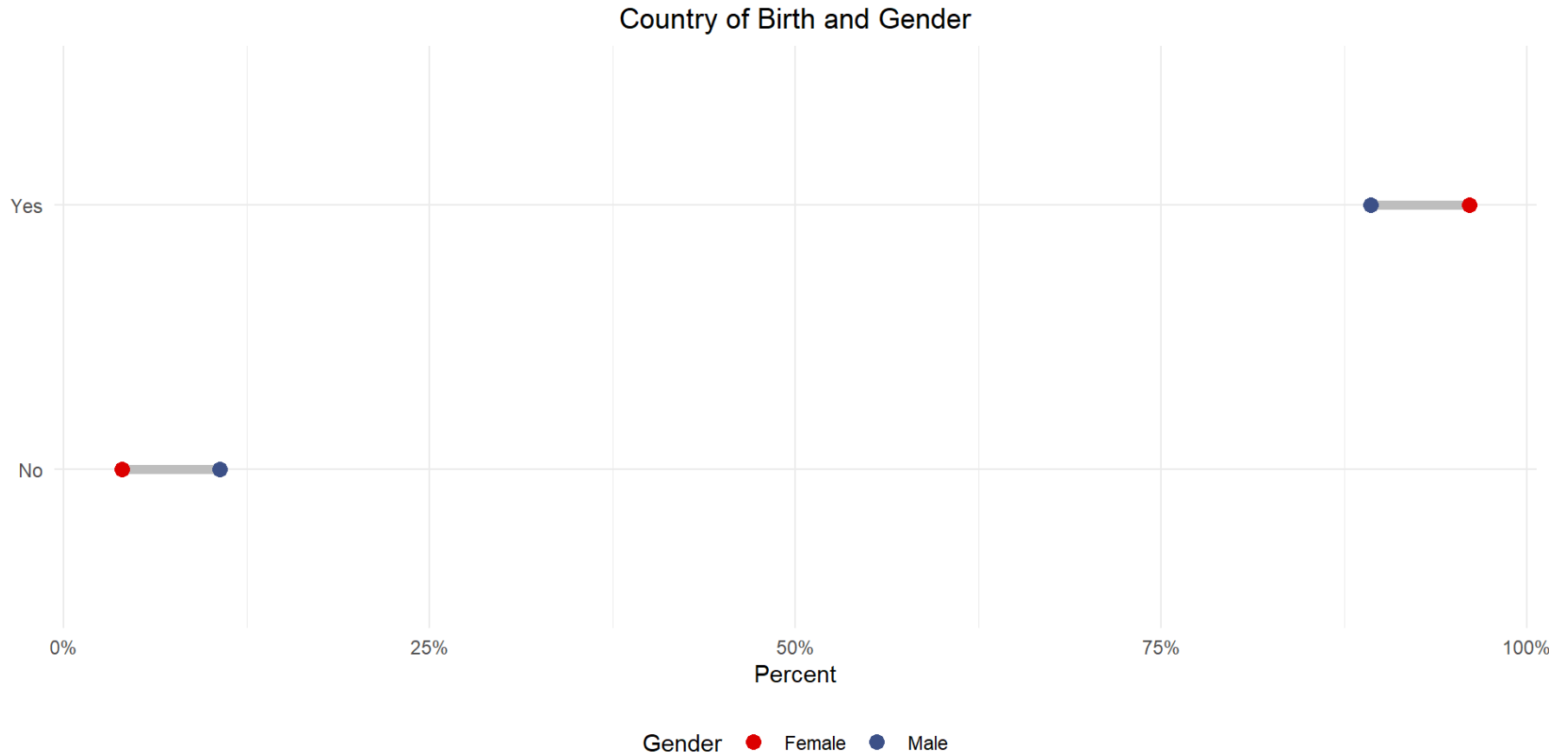

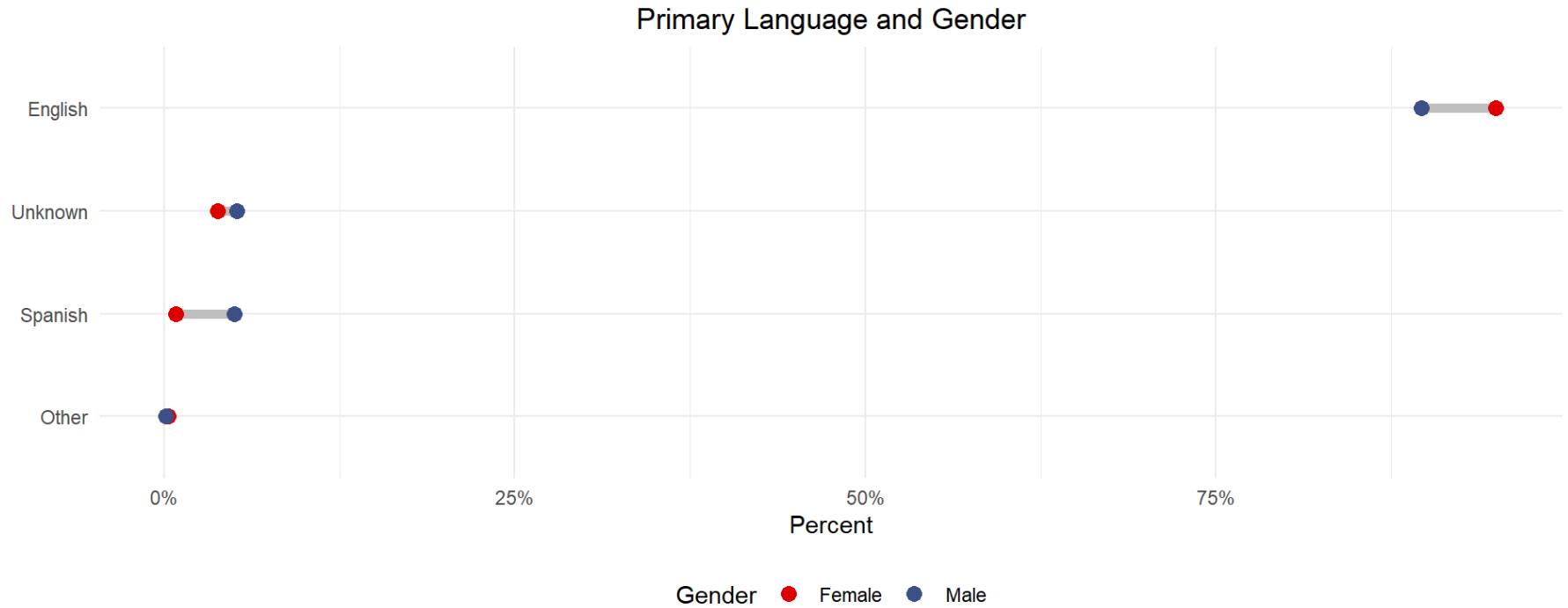
Country of Birth

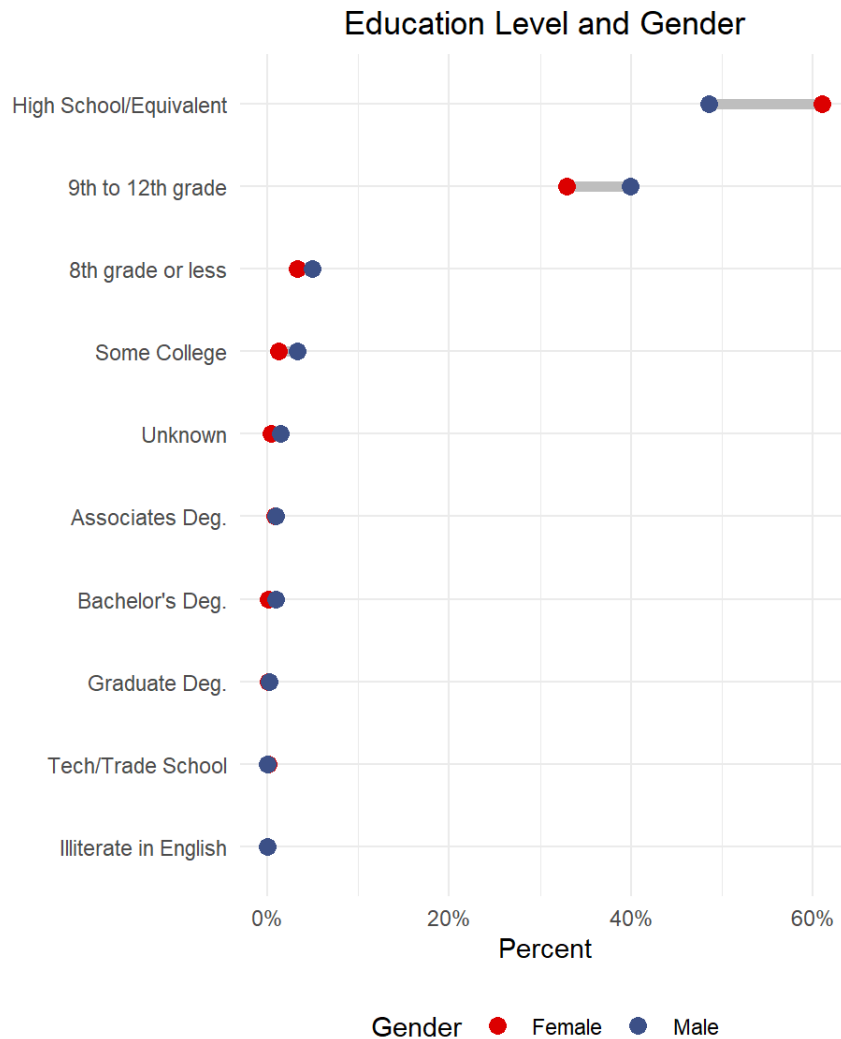

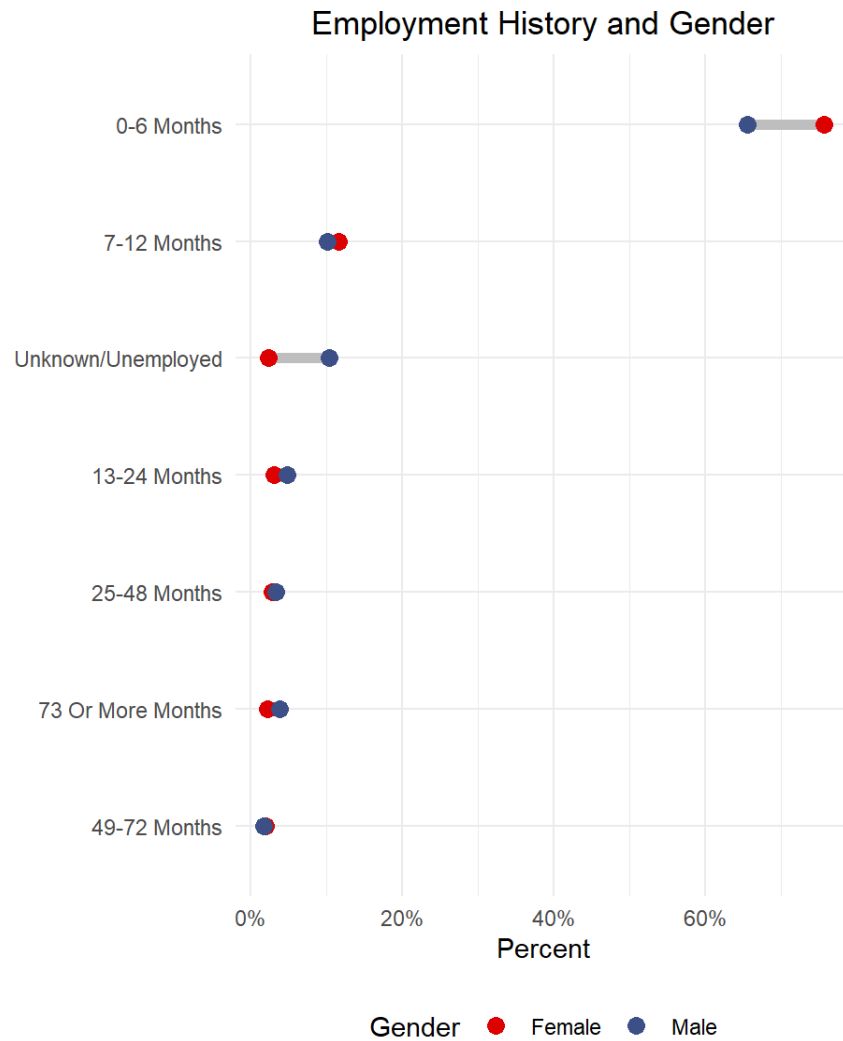

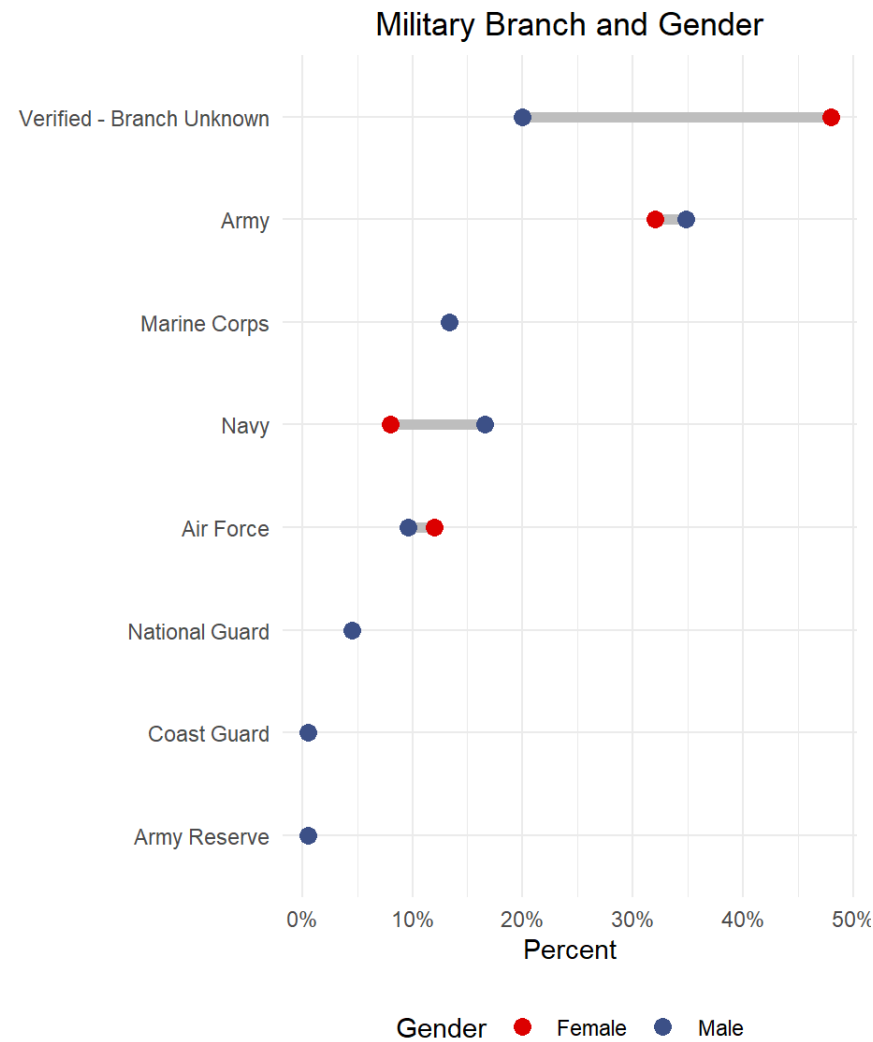
Employment/Enrollment before Incarceration

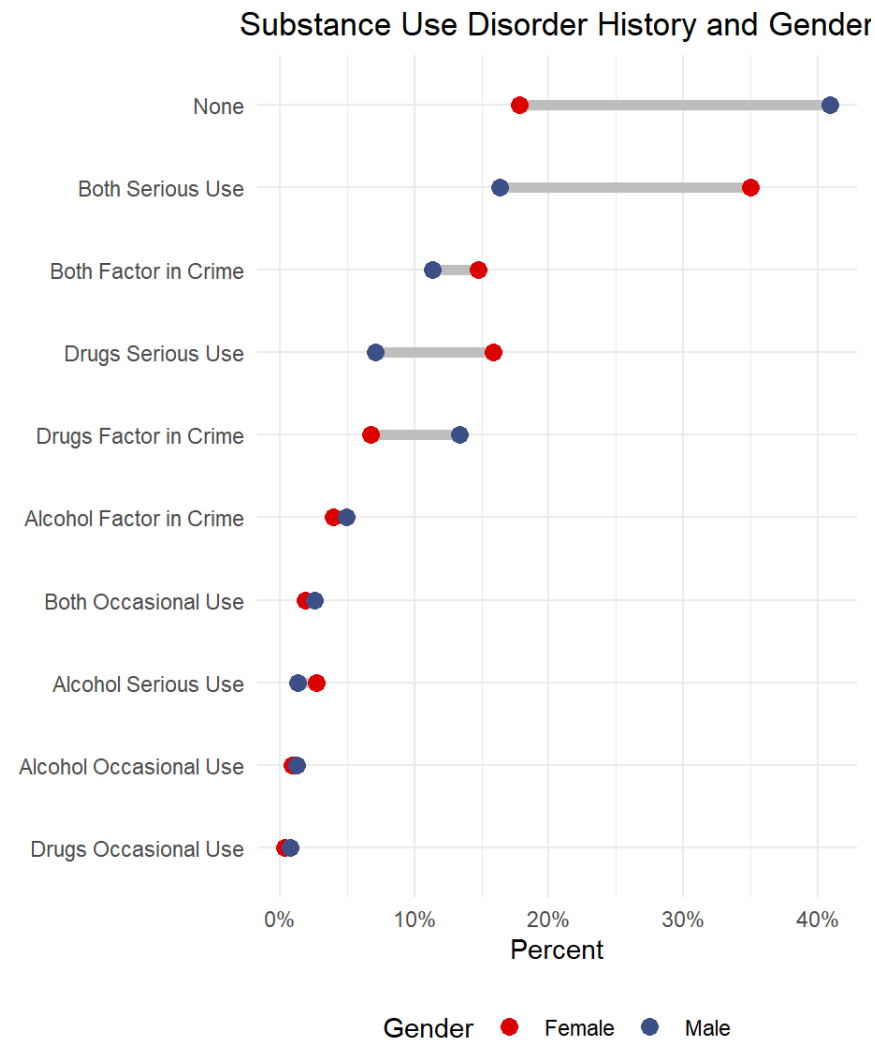

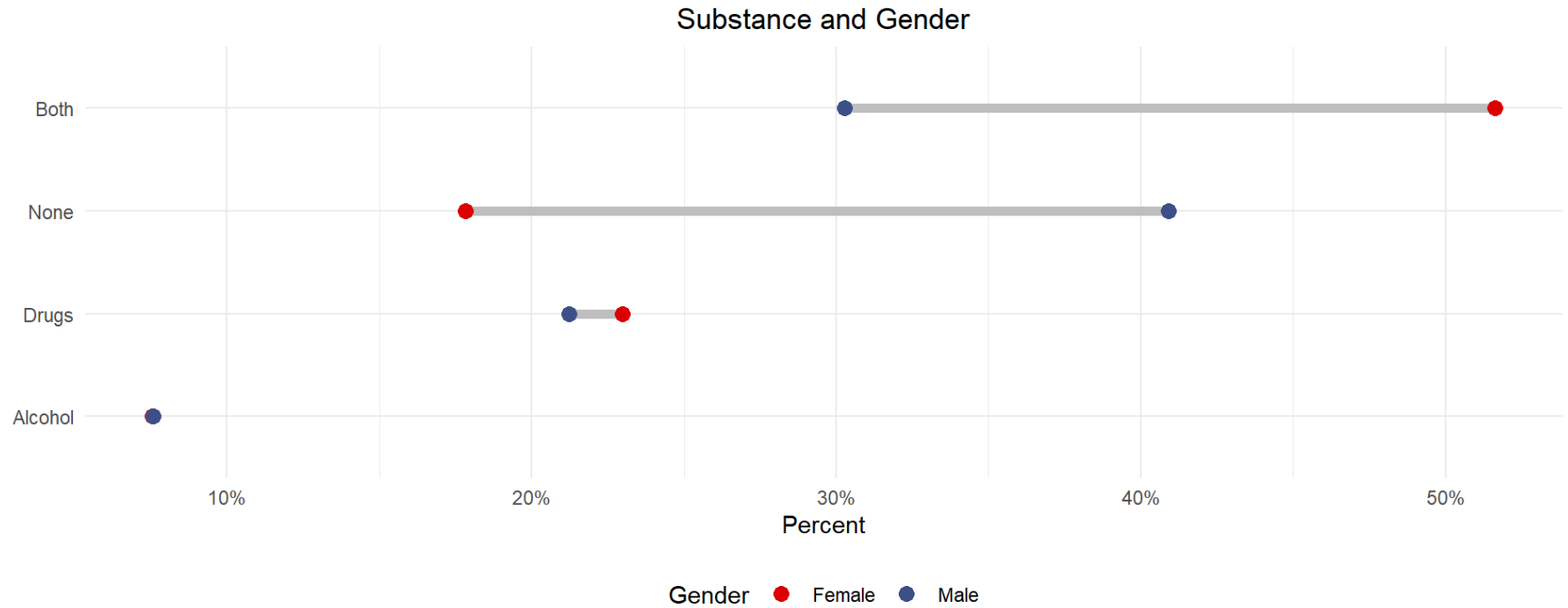

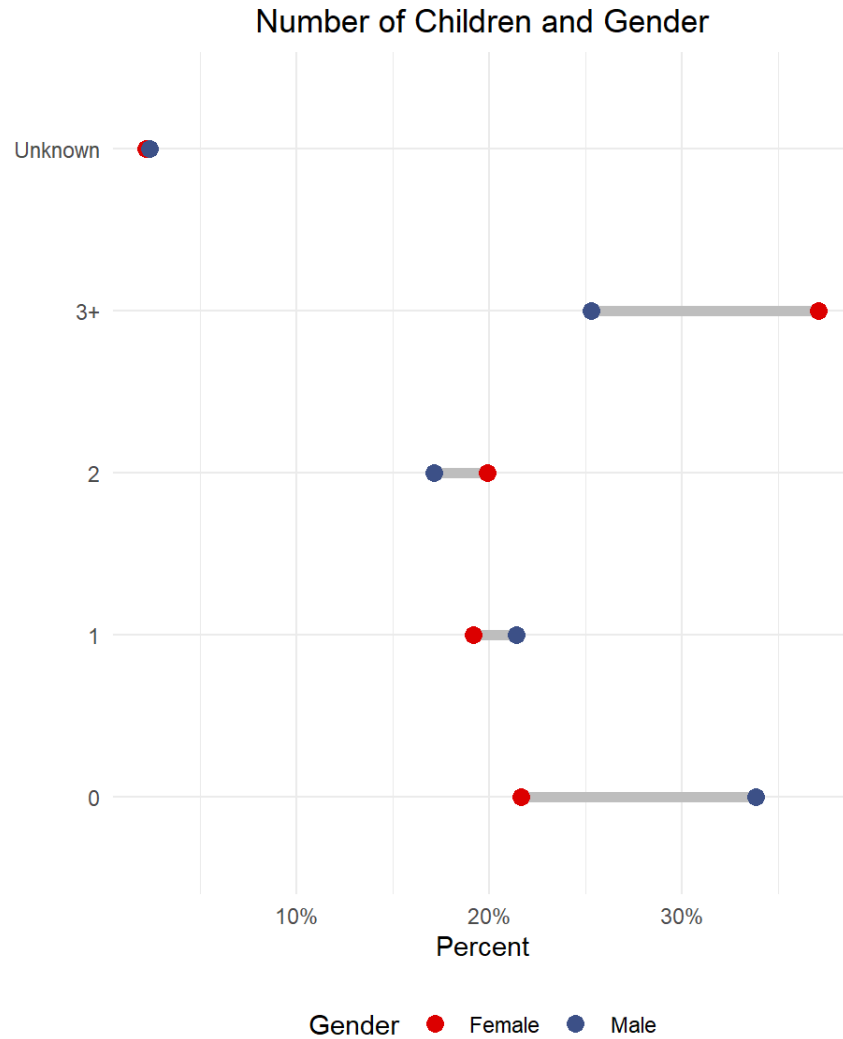

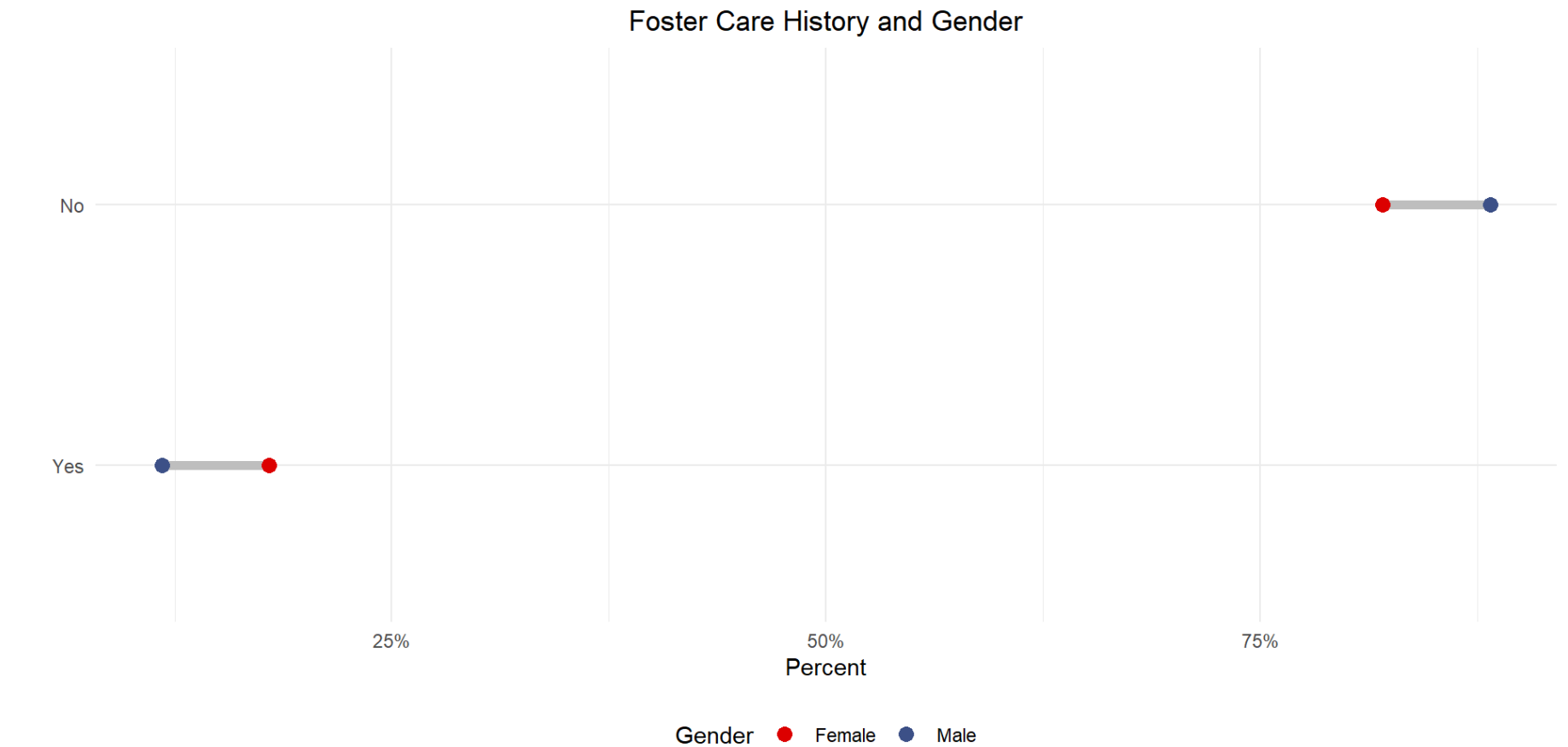

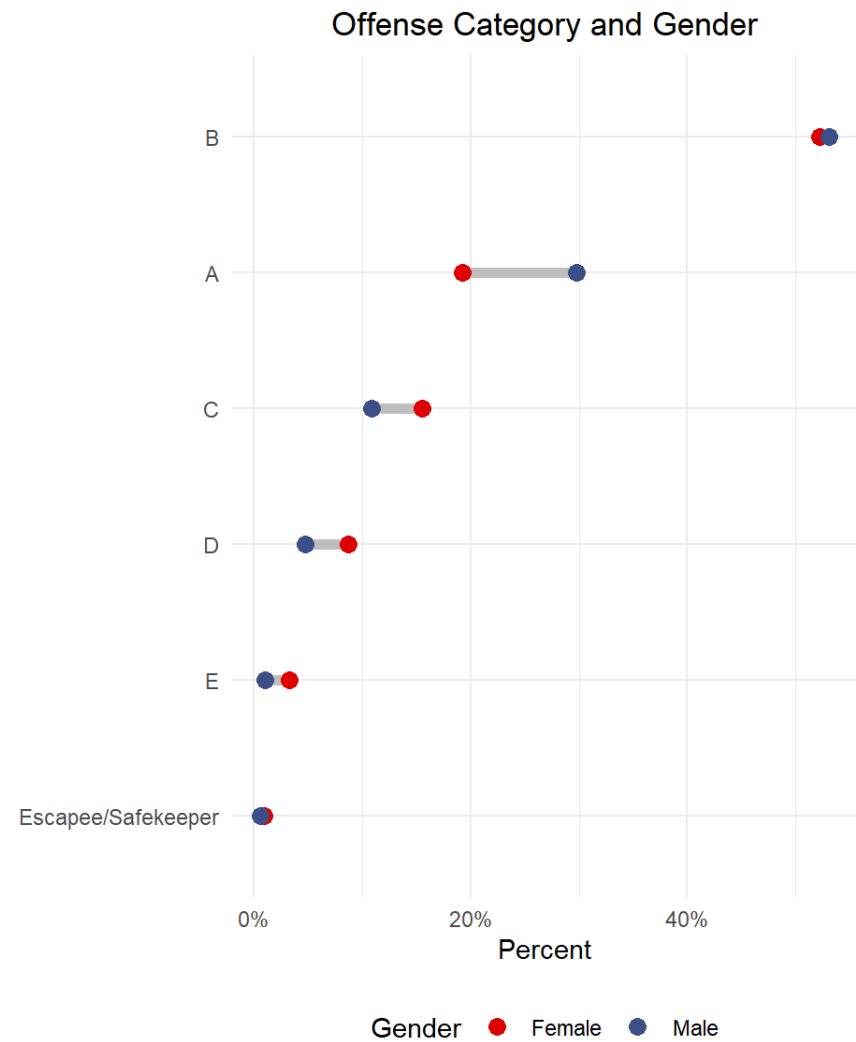

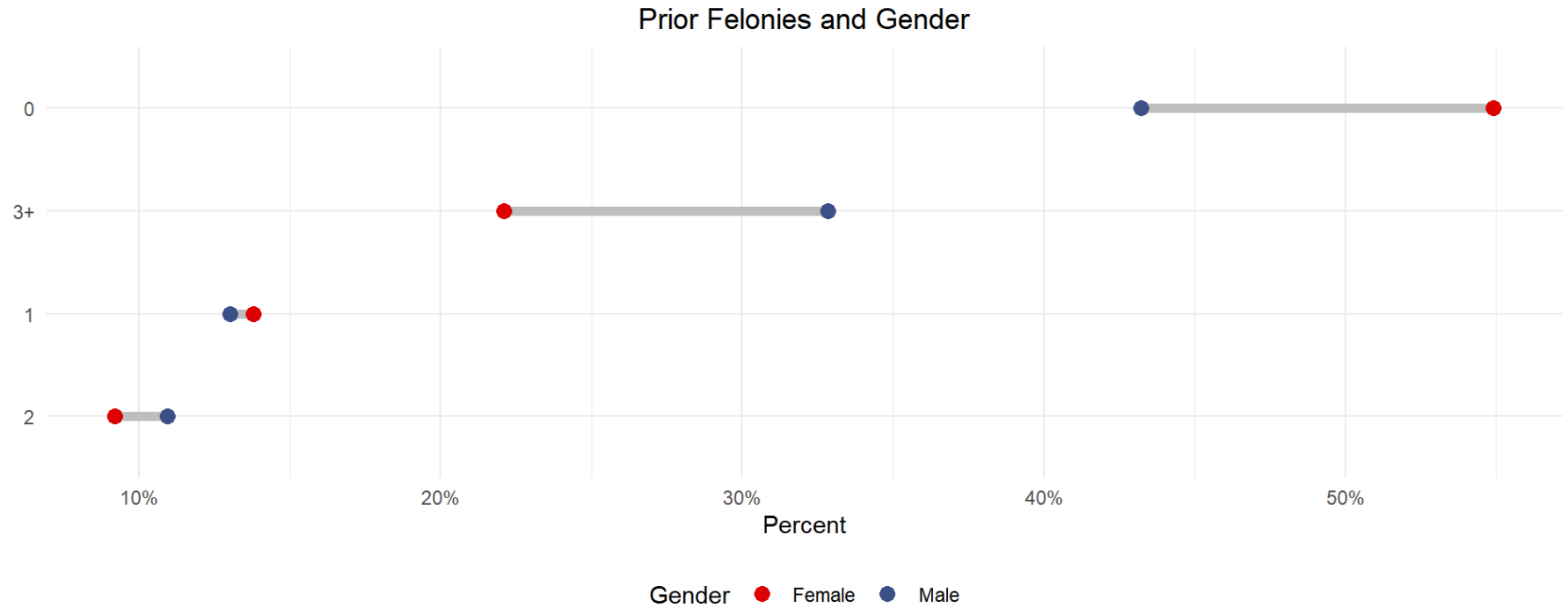

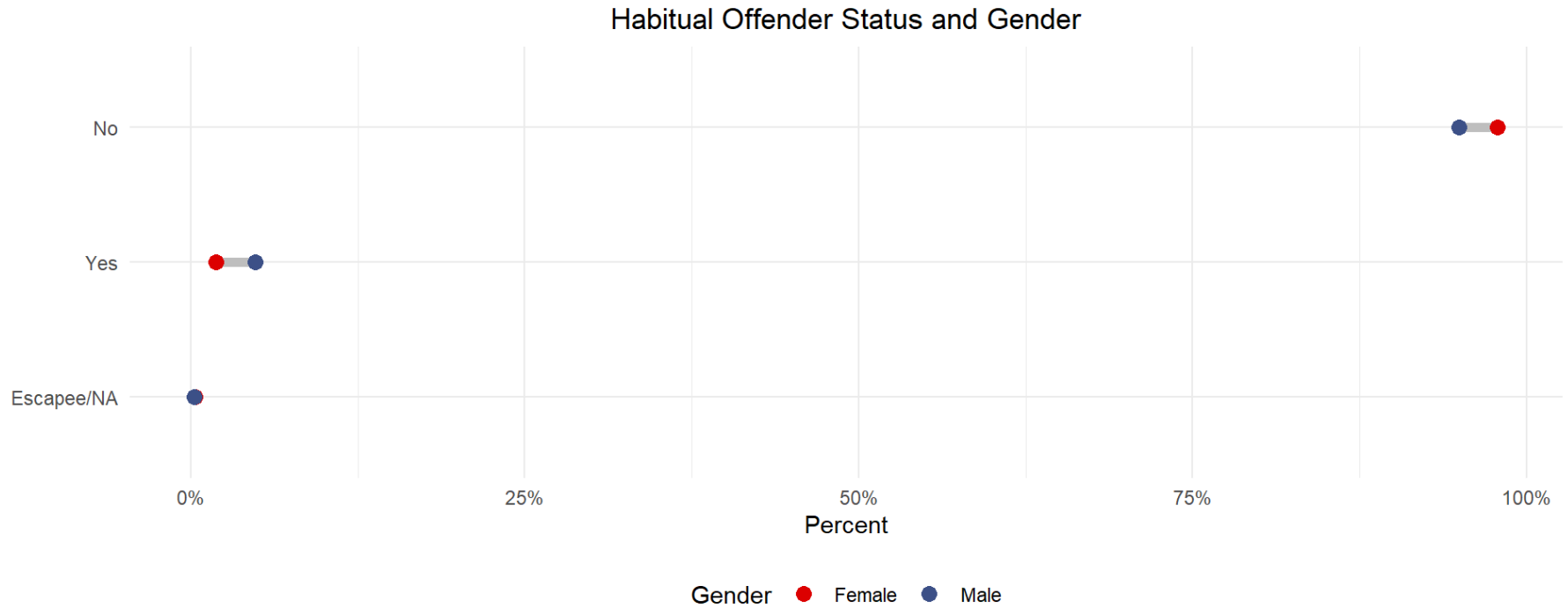

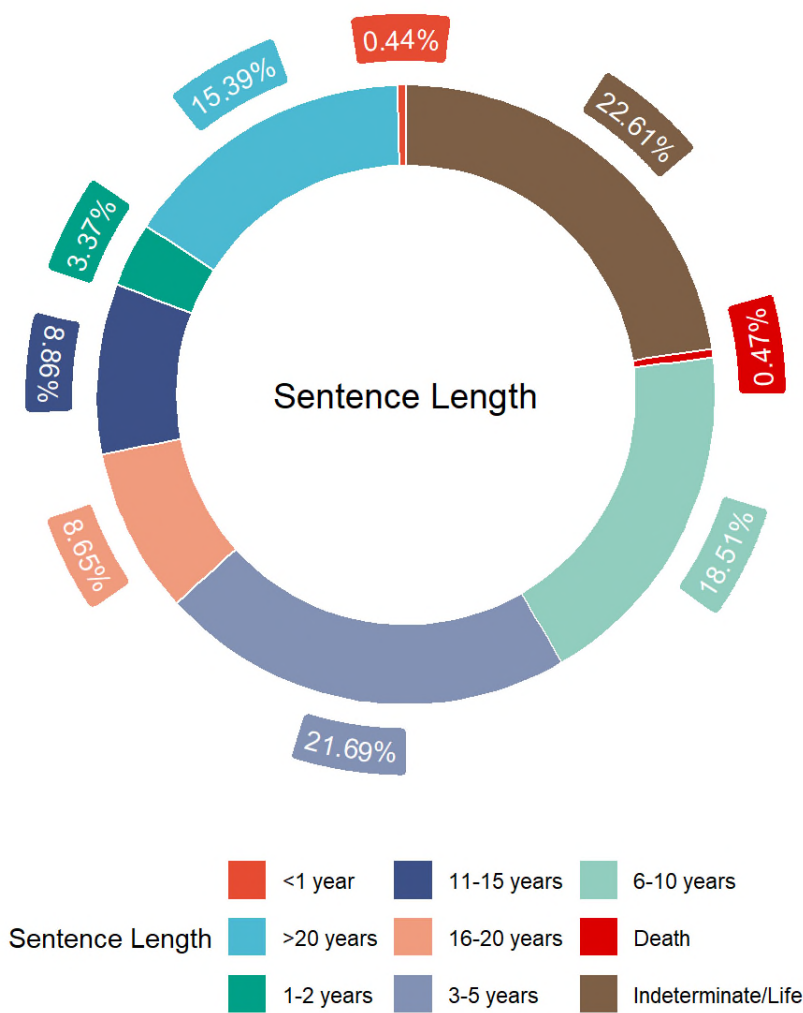

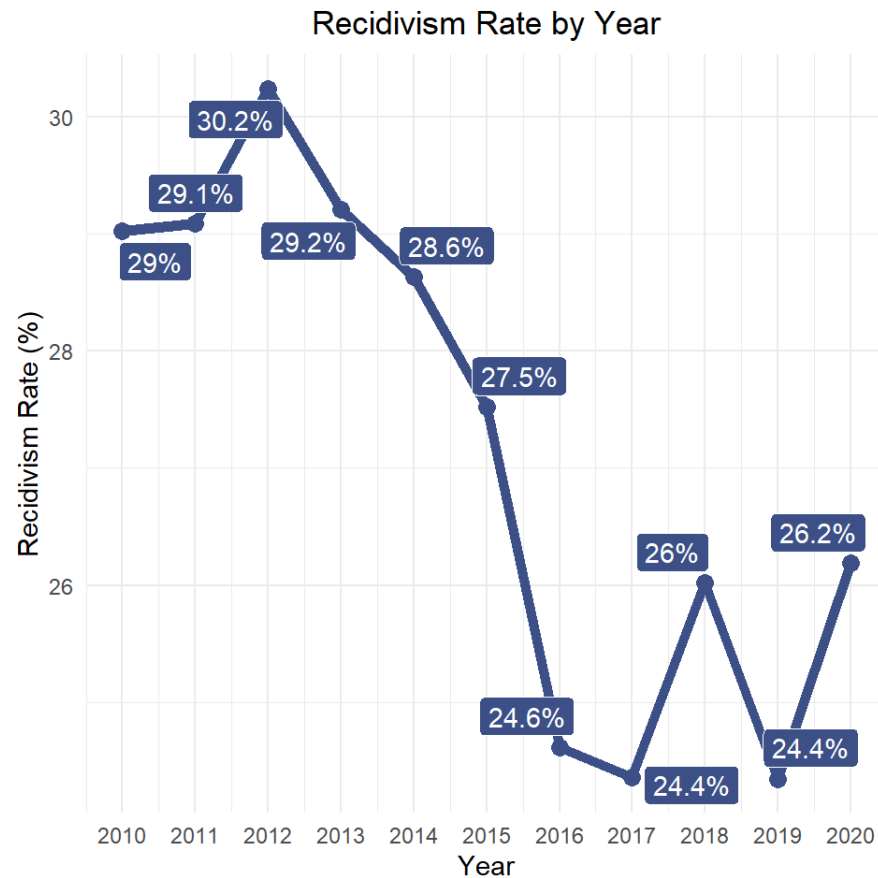

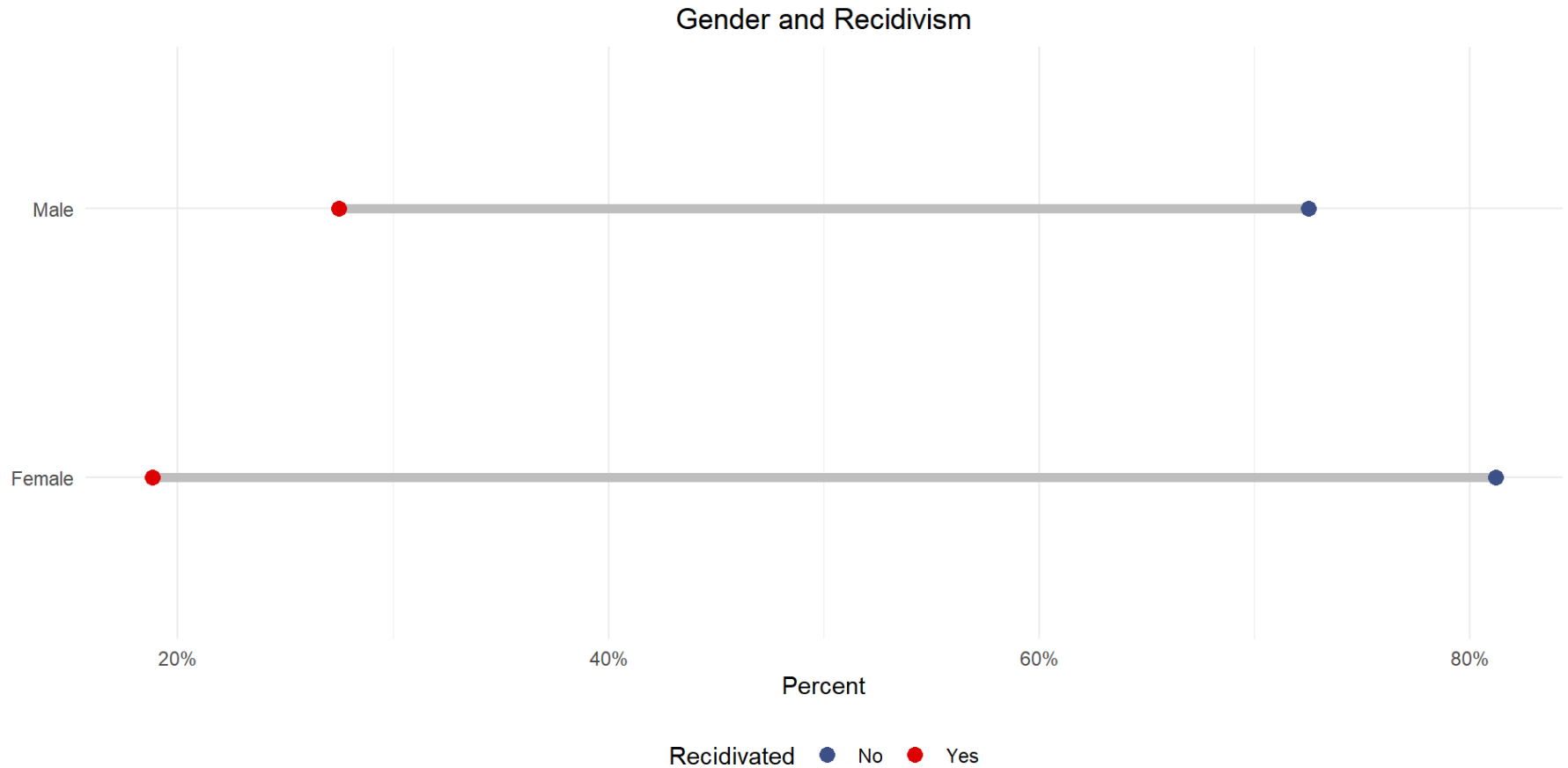

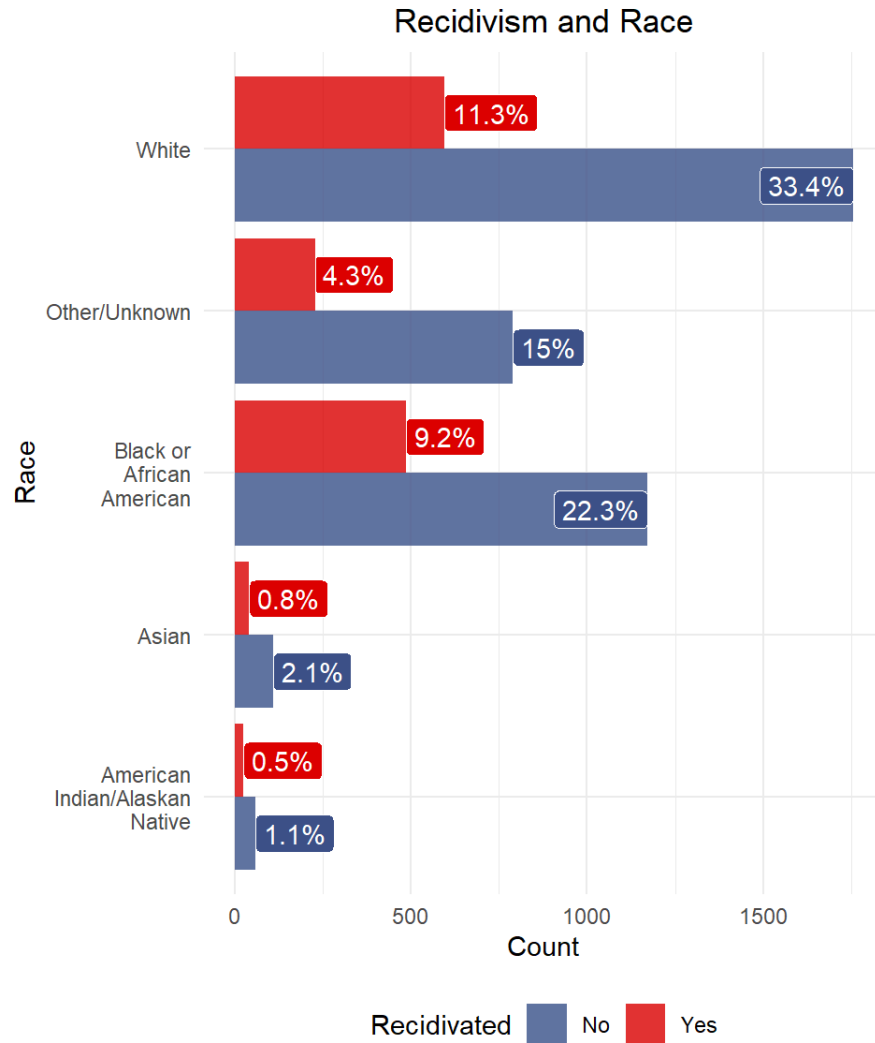

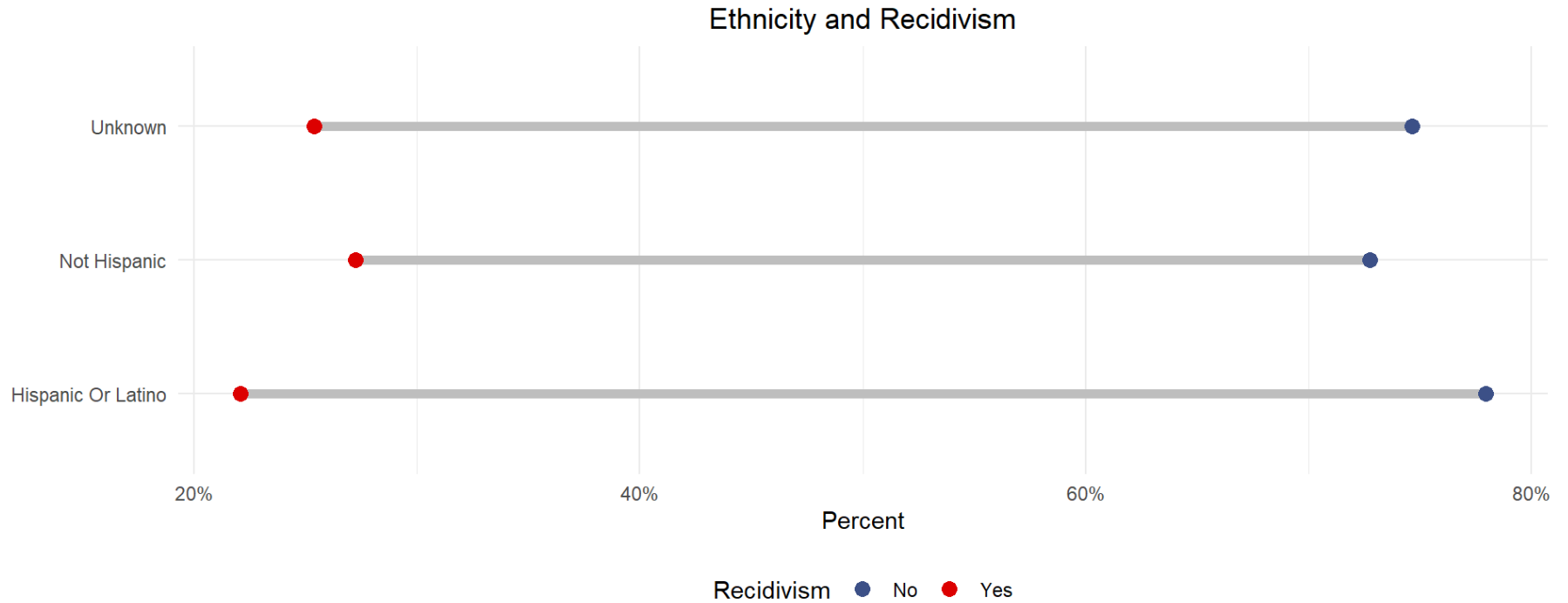

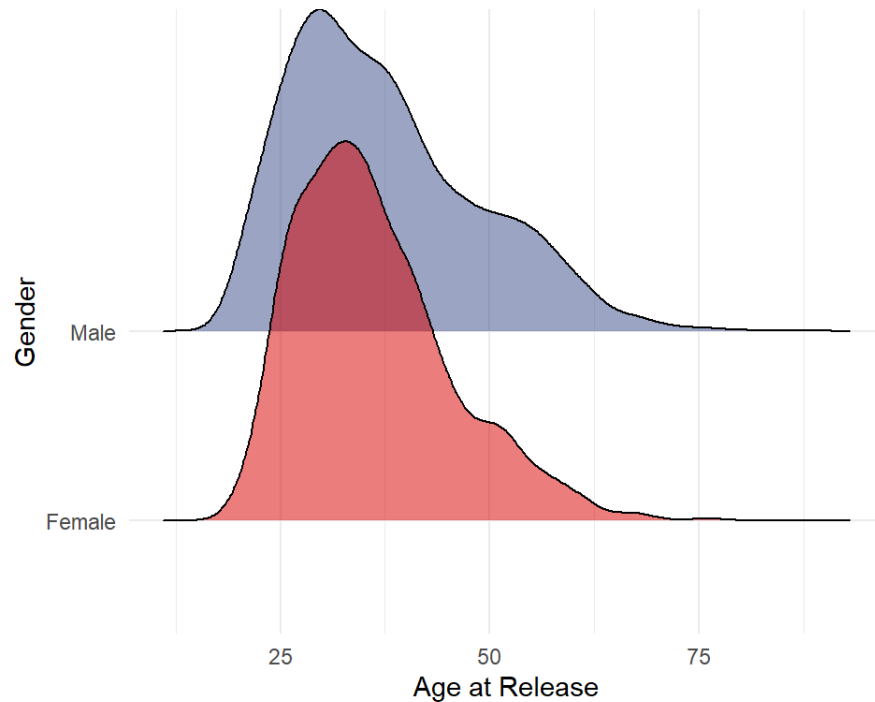

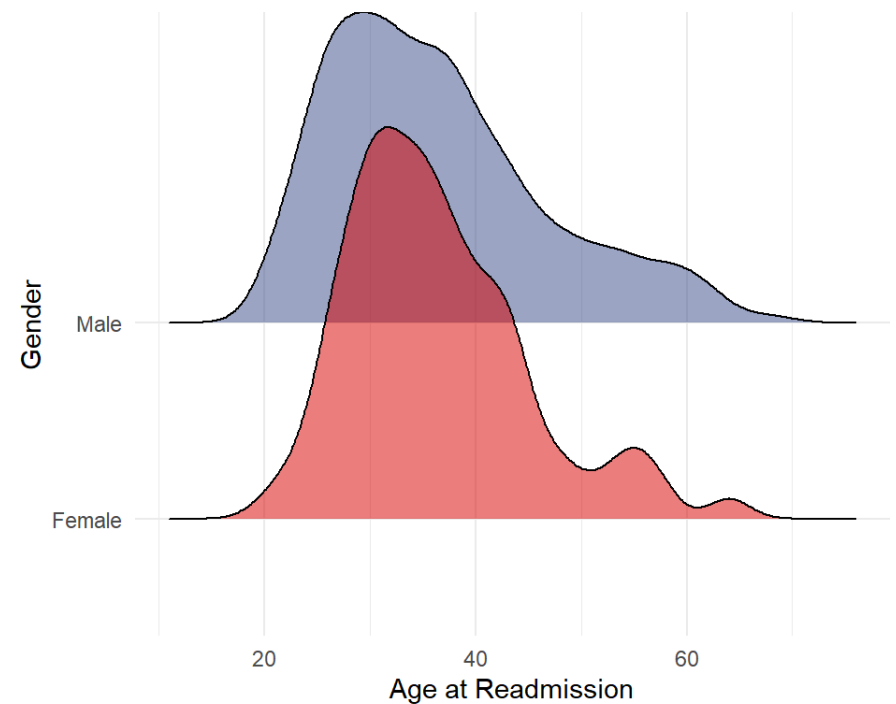

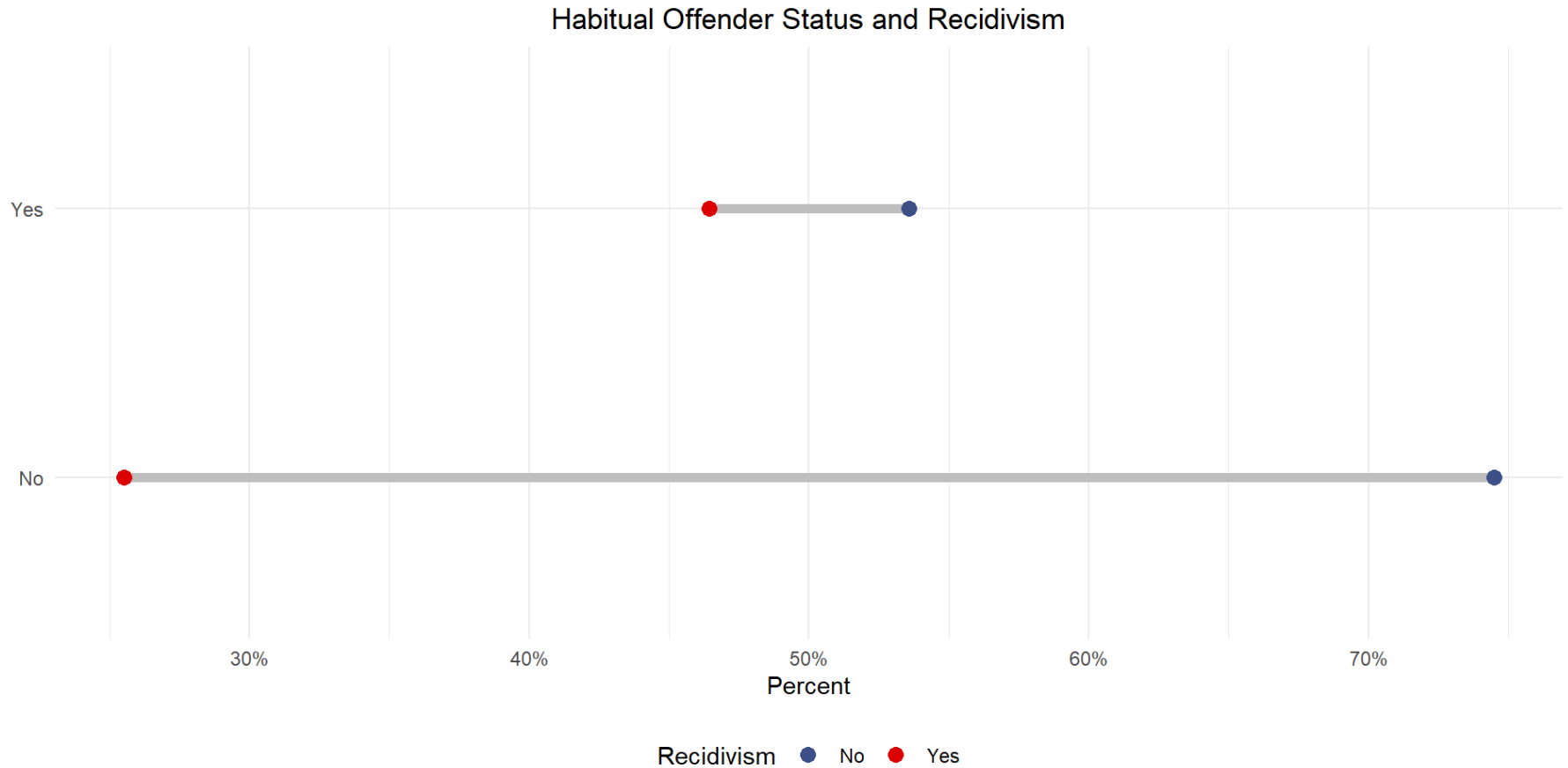


Recidivism by Prior Felonies in Nevada

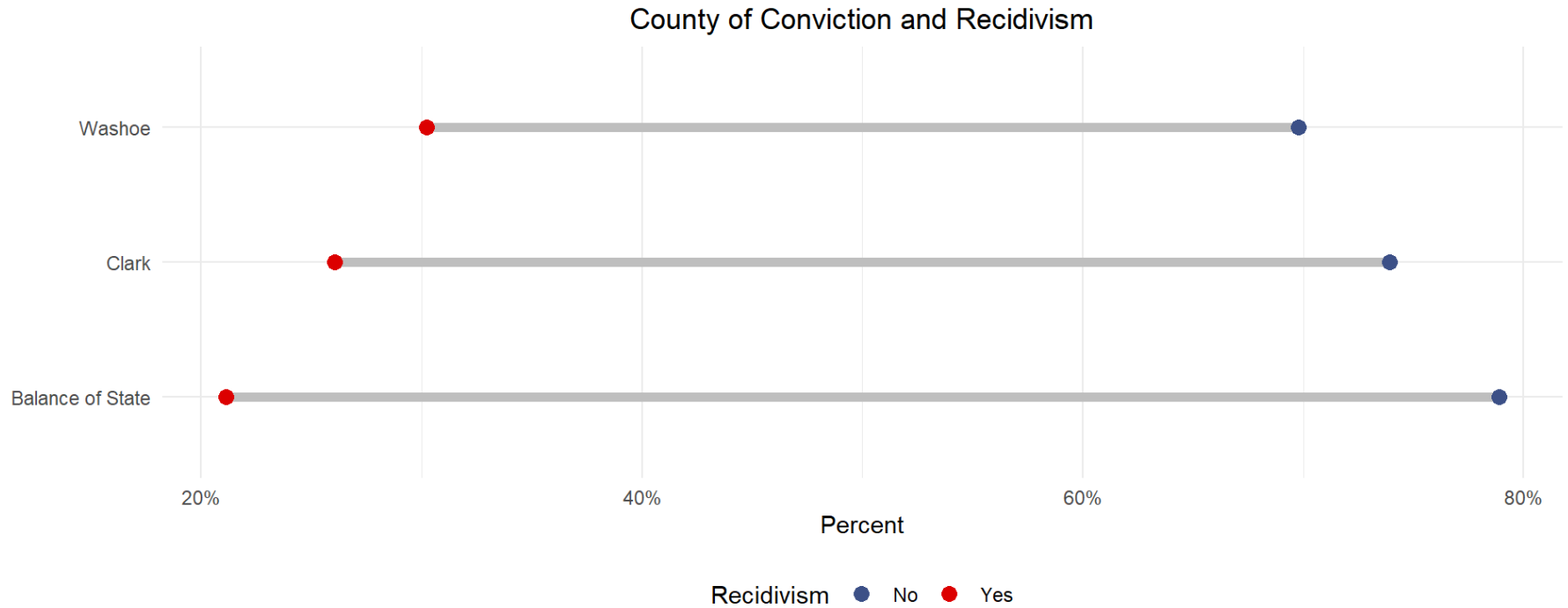

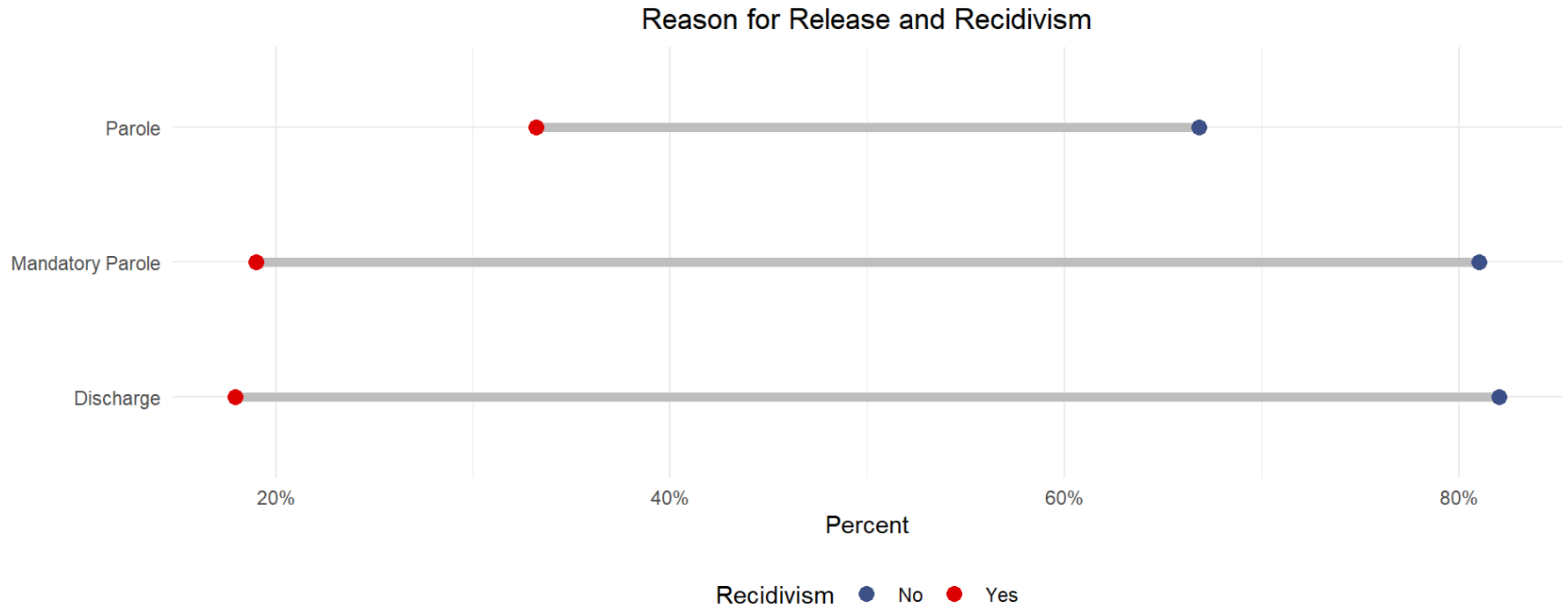

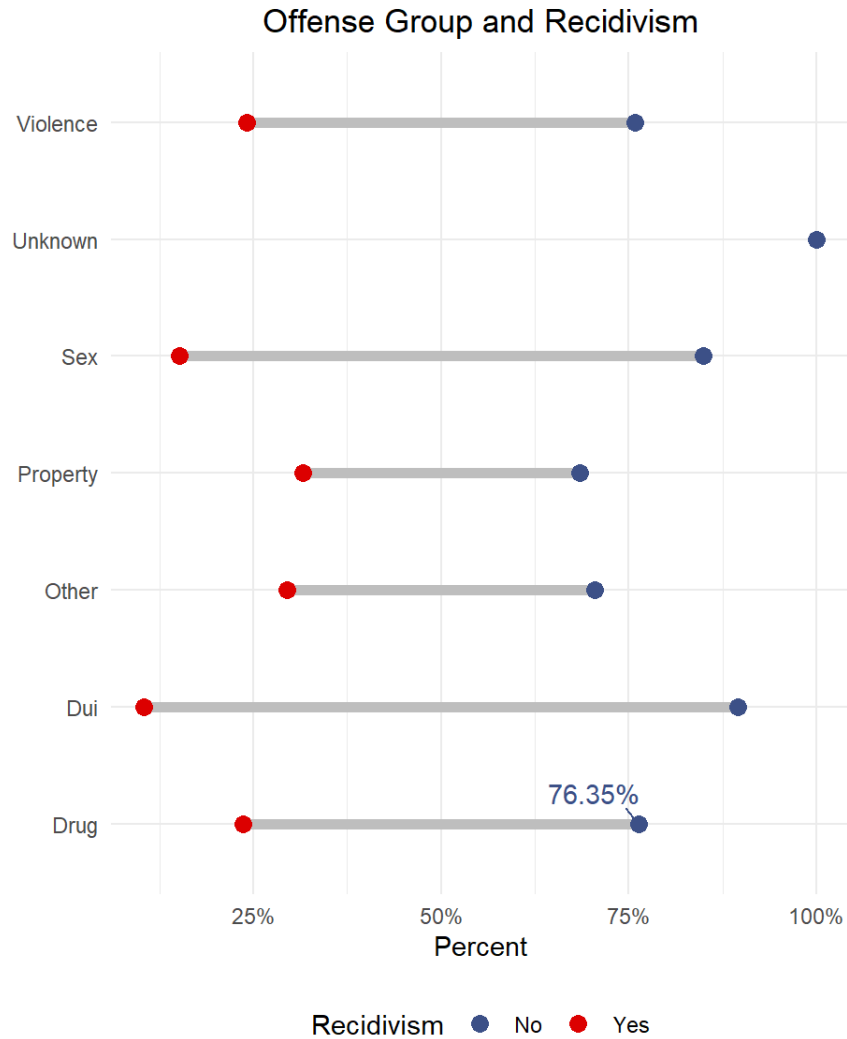
Recidivism by Release Reason

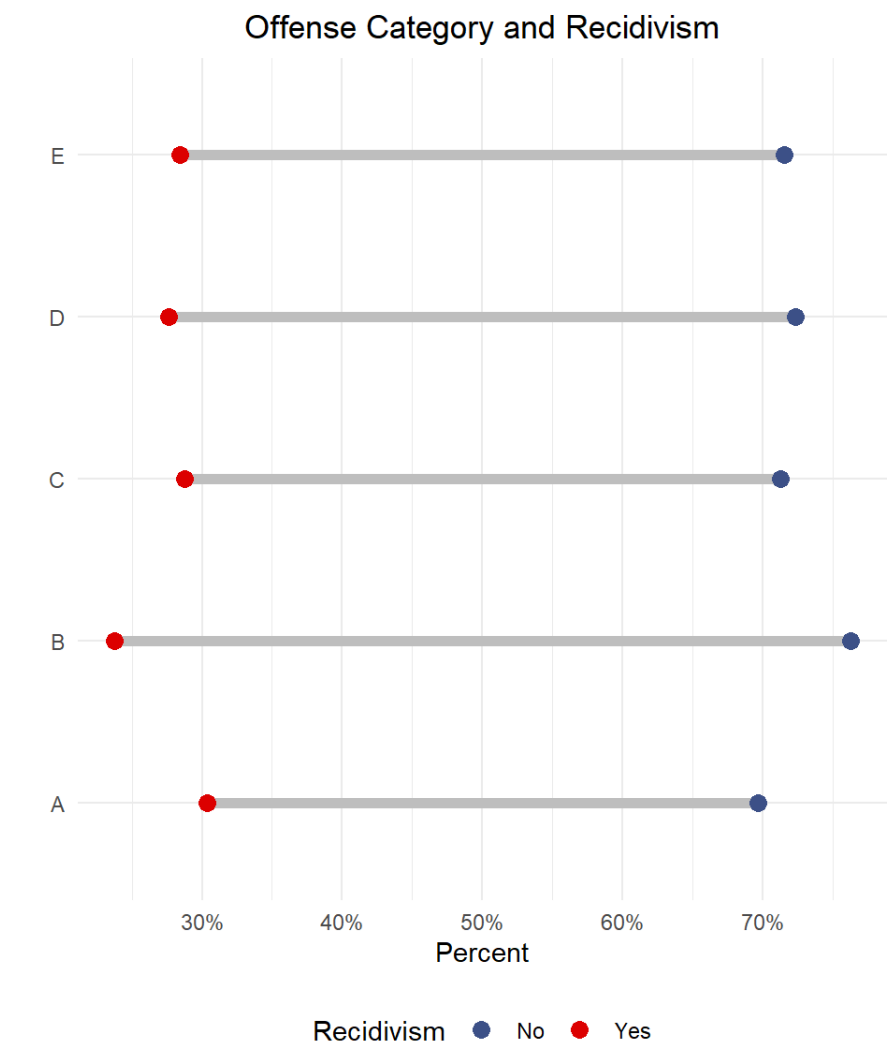

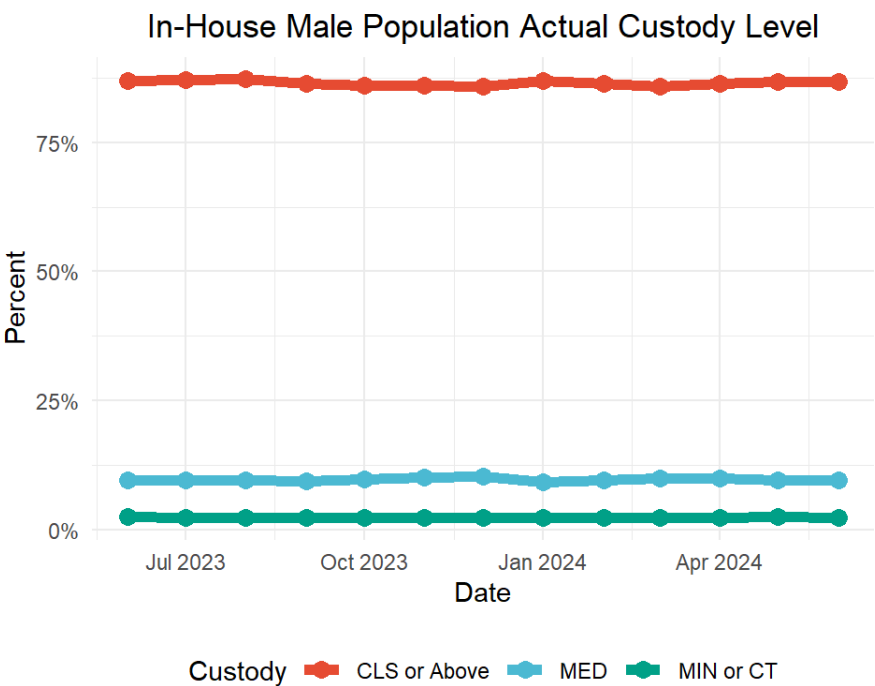

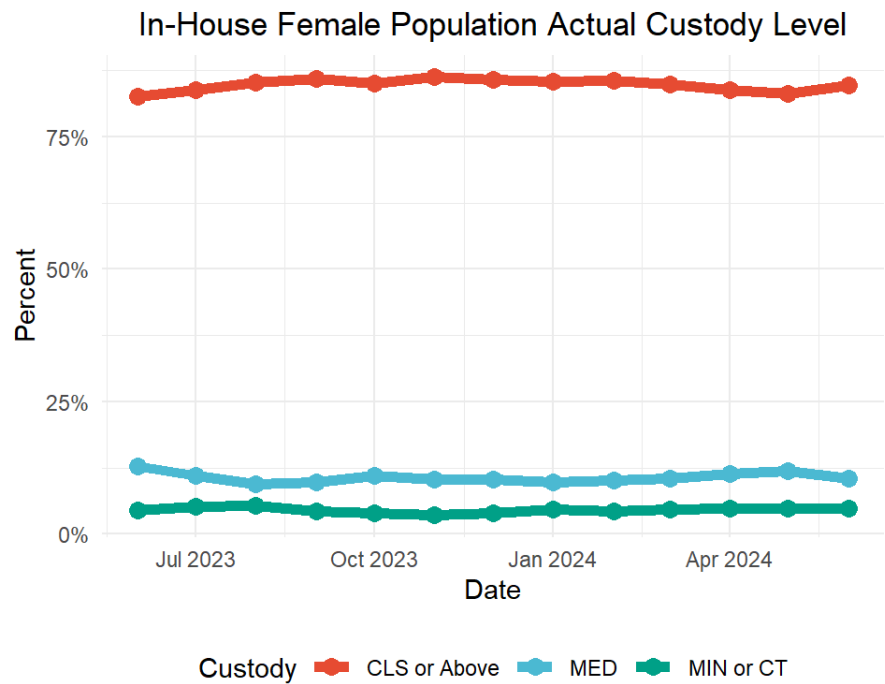

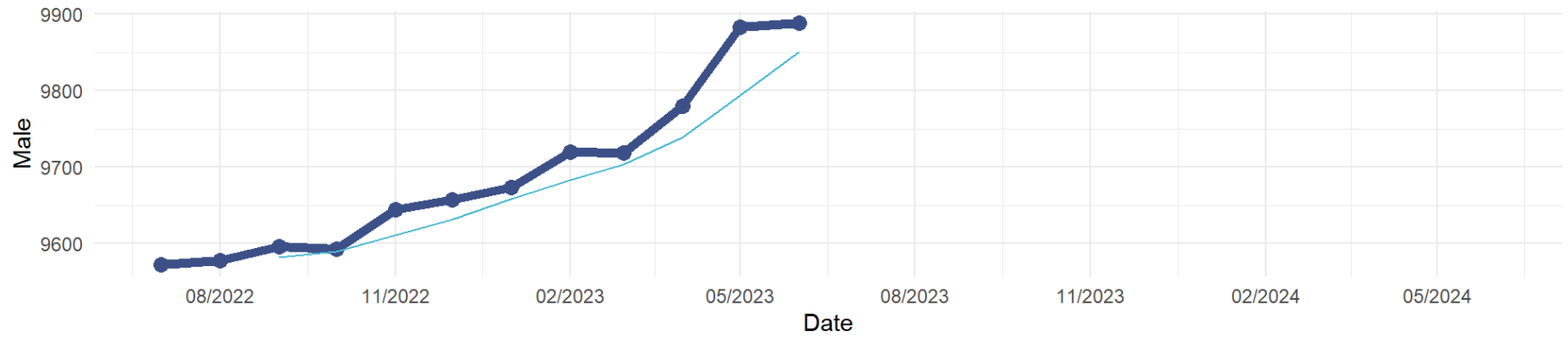

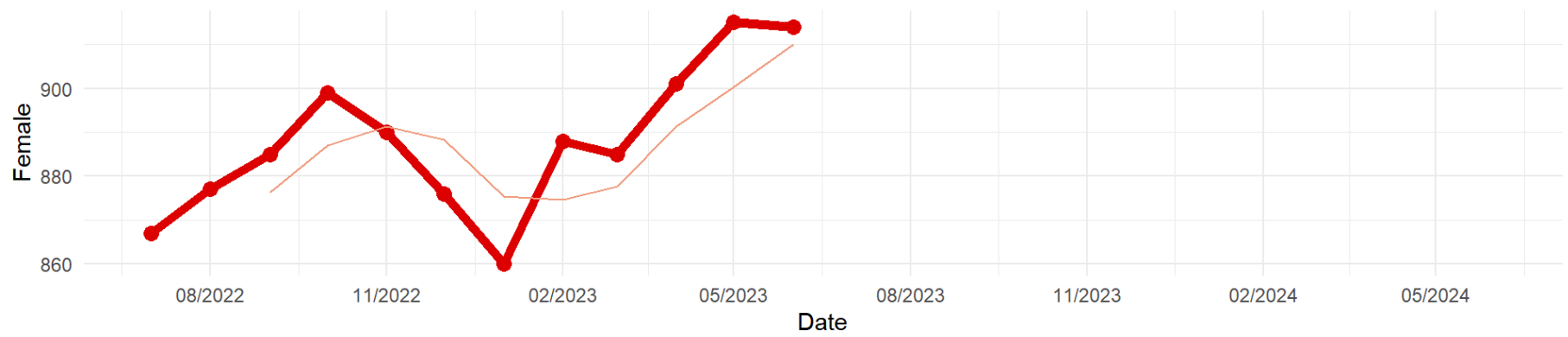
Total Correctional Population

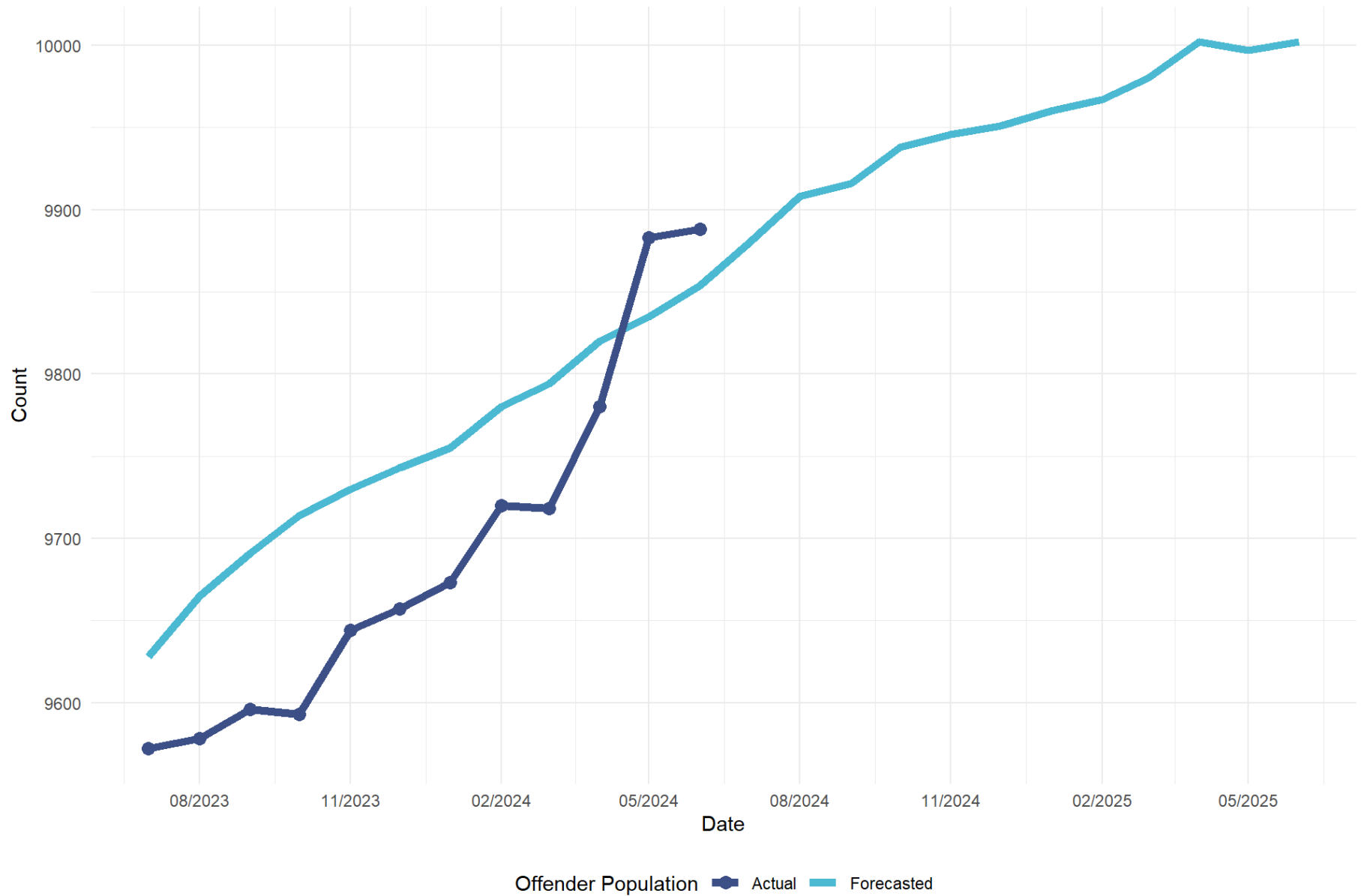

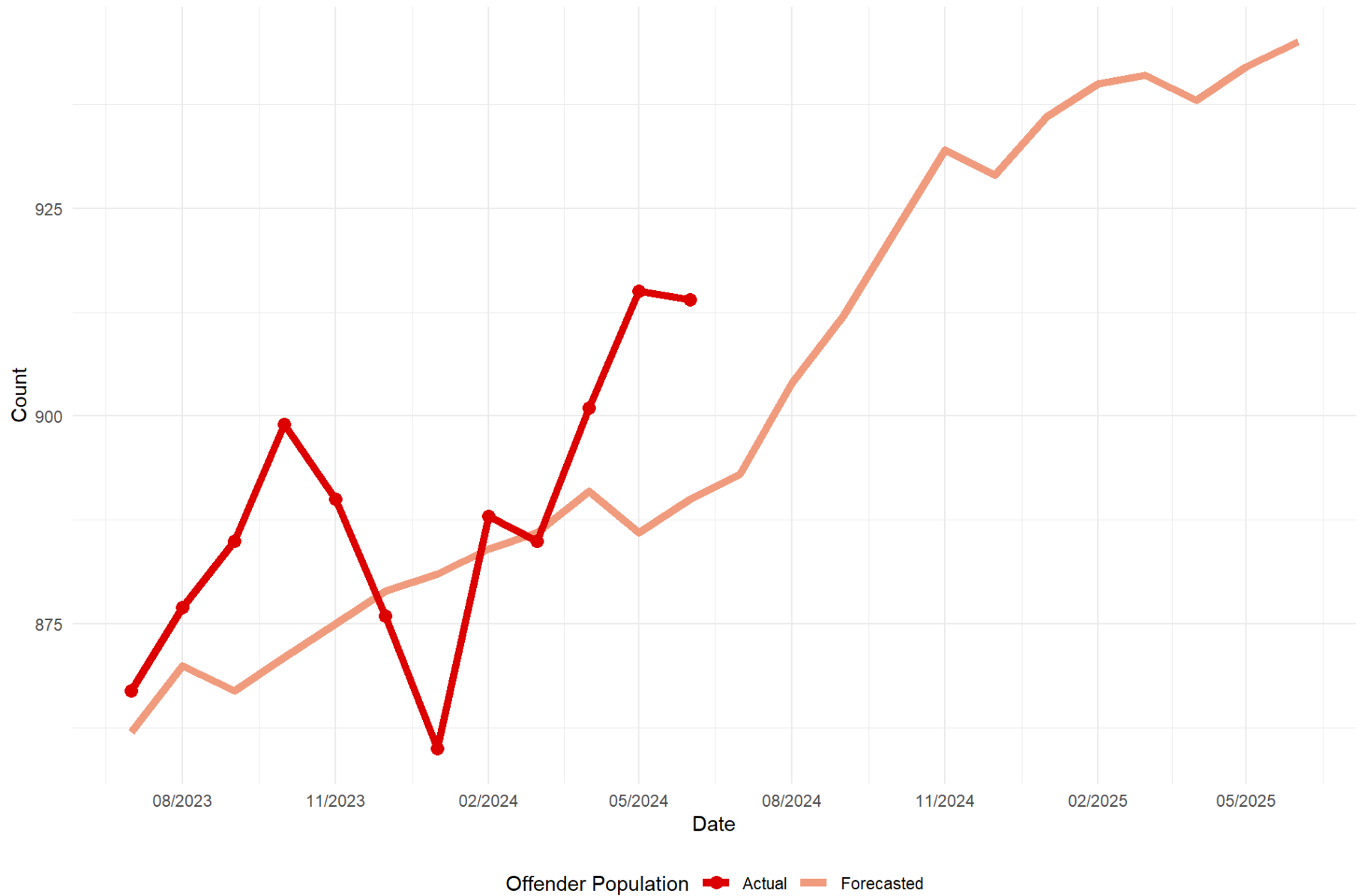

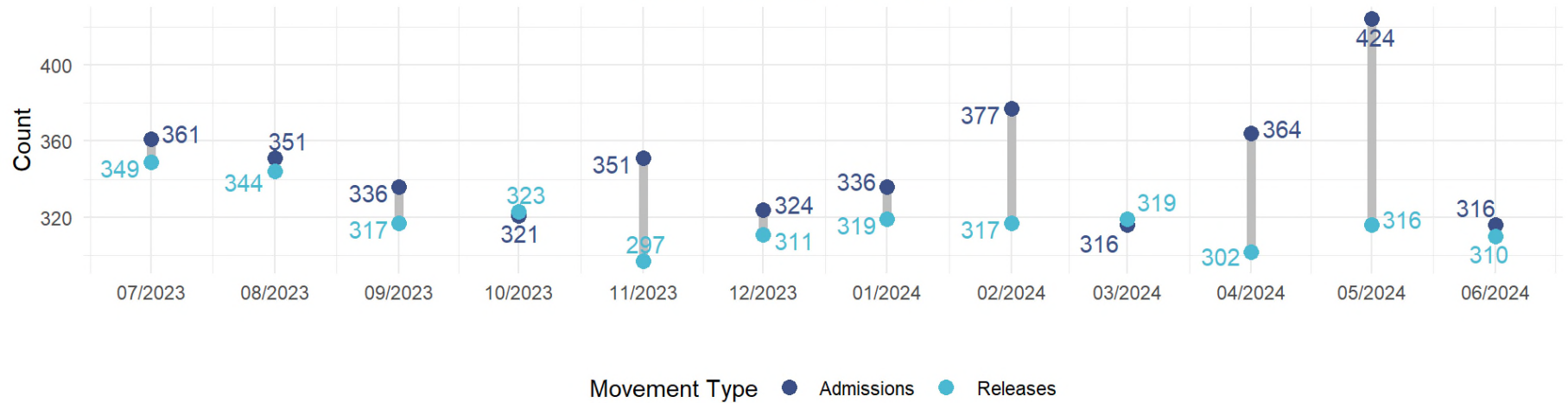

Legislatively Approved Female Total Population Projections (Current Biennium)

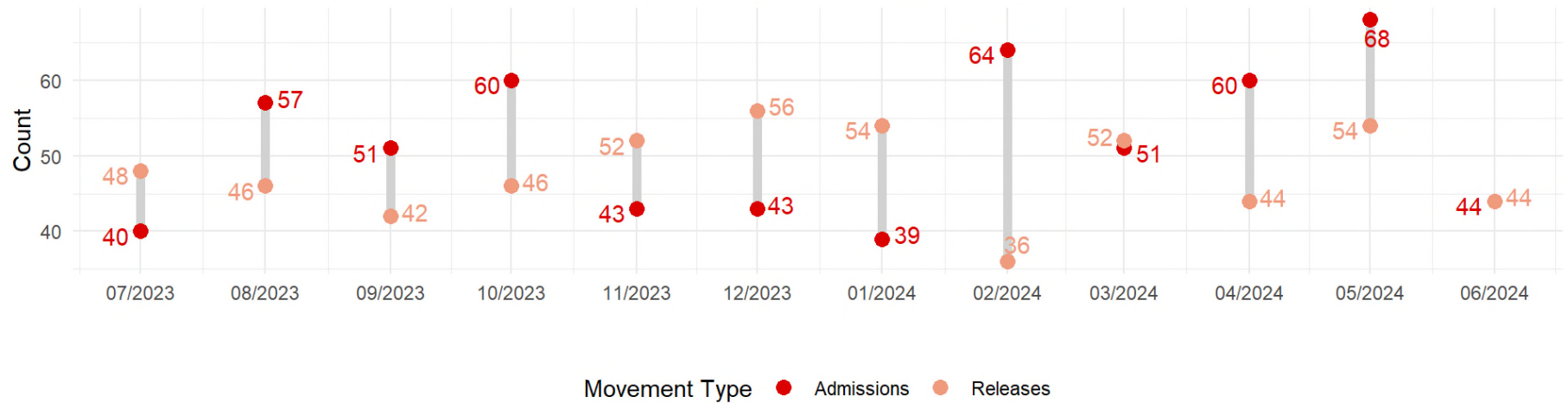


Admissions and Releases Trends

Male Admissions and Releases

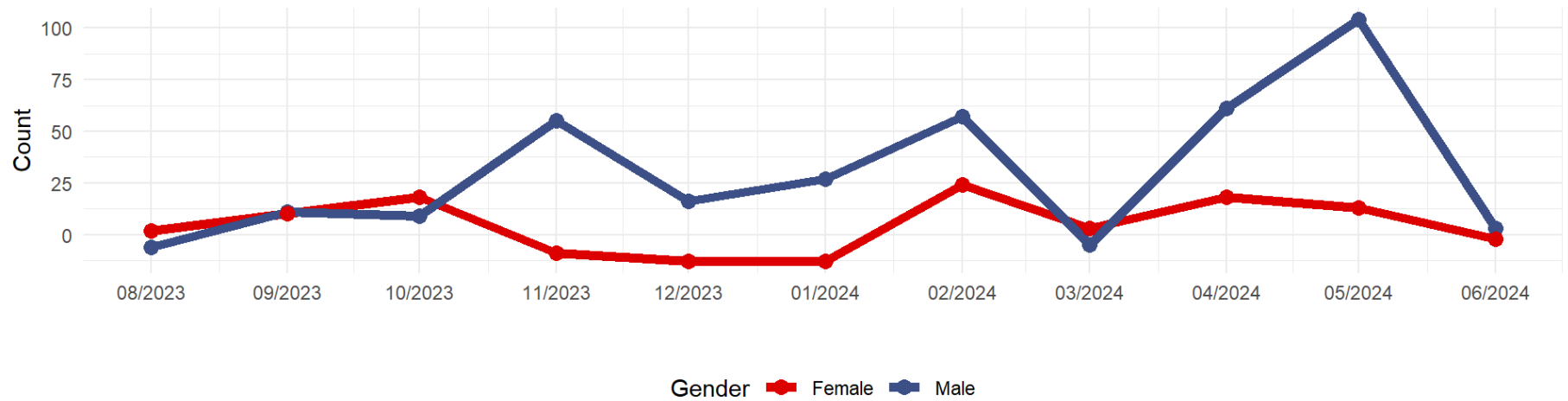

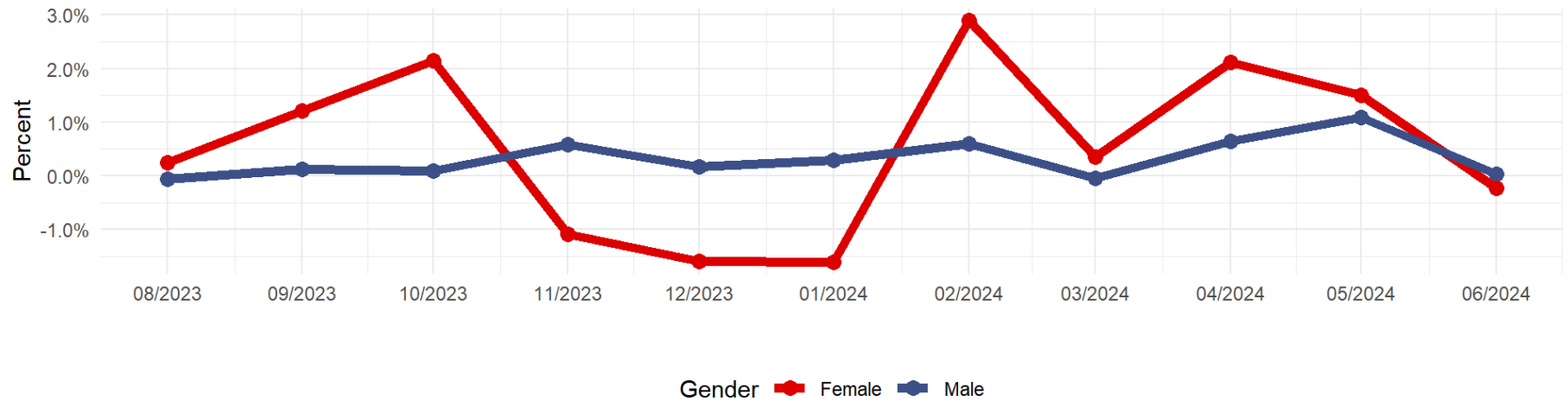


Changes in Population

Monthly In-House Population Change

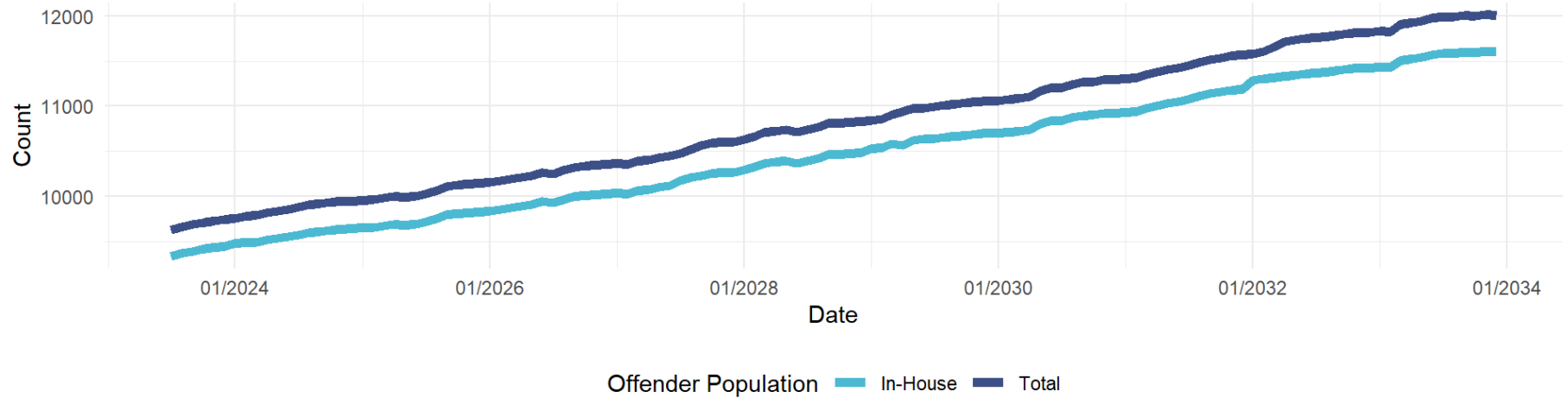


Monthly In-House Population Percent Change

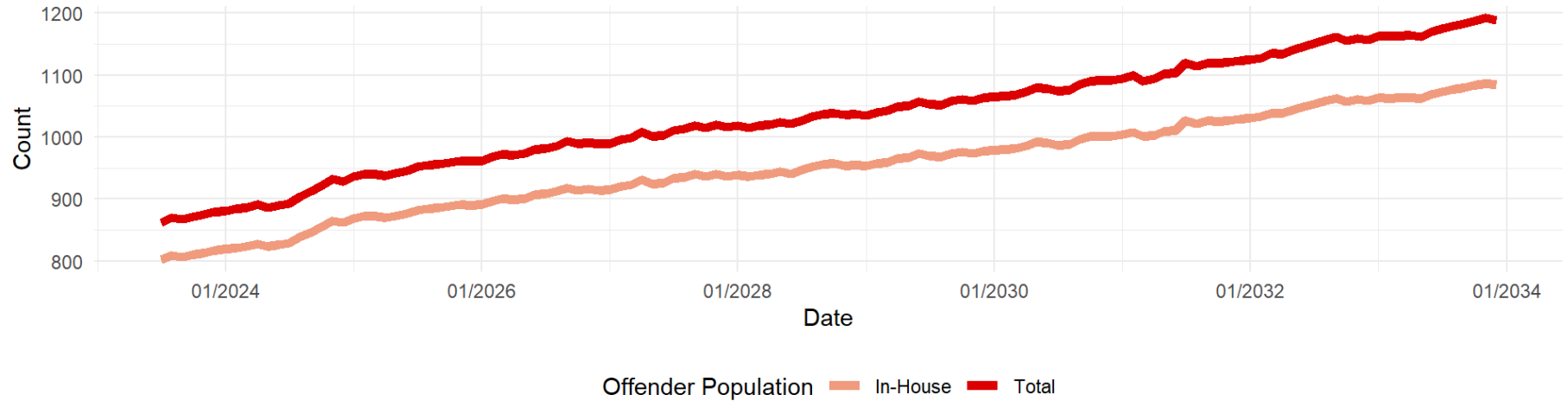


Legislatively Approved Population Forecasts

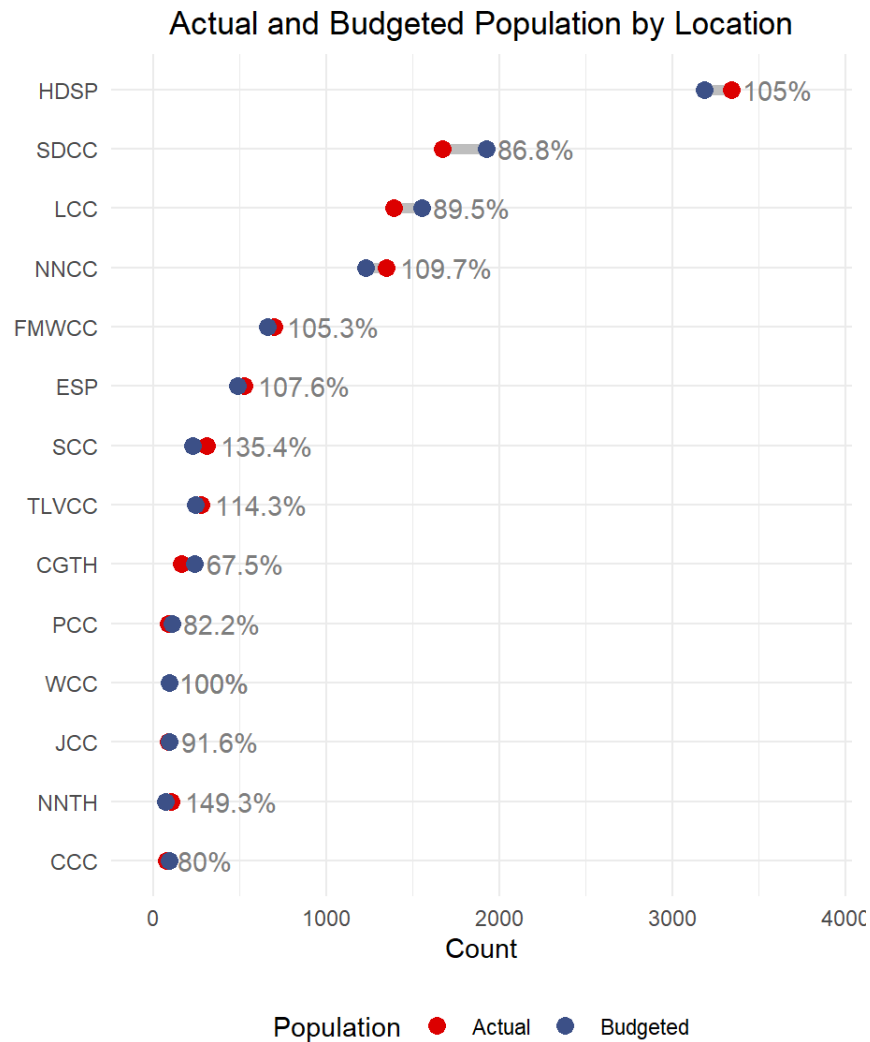
