<sup>b</sup> Nevada Department of Corrections InfoView Data Warehouse. Note: 200 individuals are housed in a private facility and are accounted for in the total population for statistical purposes. However, the cost of housing these individuals was an additional operating expense added to the FY 2019 budget and this cost is not reflected in the figures above. Beds are rented on a temporary basis to reduce overcrowding and improve programming efficiency. On August 20, 2018, this figure was adjusted upwards with the correct number of individuals on escape status.

<sup>c</sup> Legislatively approved costs. Note, as of Fiscal Year 2018, the NDOC no longer has transitional centers. NNTH and CGTH are both transitional houses.

<sup>d</sup> Nevada Department of Corrections, InfoView Data Warehouse, as of the end of the most recent month. The distribution as of the last day of the month is applied to the in-house population as of the day of the fact card. The close category includes offenders in close custody as well as those who have not been assigned to a custody level as of the last day of the month. Offenders housed in private prisons are excluded from this distribution.
