<sup>a</sup> Filled or approved FTEs include positions supported by the Nevada General Fund as well as externally funded positions, including the inmate store, the inmate welfare account, prison industries, and the dairy farm. Filled position figures are as of the date of the data extract from the Nevada Human Resources Data Warehouse.

<sup>b</sup> Total population counts are retrieved from Nevada Department of Corrections InfoView Data Warehouse or NOTIS Web. Note: 100 individuals are housed in a private facility and are accounted for in the total population for statistical purposes. The cost of housing these individuals was an additional operating expense added to the FY 2019 budget, and this cost is not reflected in the figures above. Beds are rented on a temporary basis to reduce overcrowding and improve programming efficiency.

<sup>c</sup> Legislatively approved costs. Note, as of Fiscal Year 2018, the NDOC no longer has transitional centers. NNTH and CGTH are both transitional houses. Daily operating costs exclude the cost of providing medical care.

<sup>d</sup> Nevada Department of Corrections, InfoView Data Warehouse, as of the end of the most recent month. The distribution as of the last day of the month is applied to the in-house population as of the day of the fact card. The close category includes offenders in close custody as well as those who have not been assigned to a custody level as of the last day of the month. Offenders housed in private prisons are excluded from this distribution.

<sup>e</sup> Nevada Department of Corrections, Nevada Offender Tracking System Web Reports. As of September 2018, offenders released on parole and housed at the NDOC's parole housing unit are no longer accounted for in the admissions caseloads and only one release will be accounted for statistical purposes.

<sup>g</sup> These number are retrieved from the Nevada Department of Corrections, the InfoView Data Warehouse, or provided by individual facilities that house offenders in disciplinary segregation. Counts are inclusive of disciplinary detention and disciplinary segregation.
