Nevada Department of Corrections (NDOC) will take reasonable steps to ensure that Limited English Proficient (LEP) persons have meaningful access and communication.

To ensure services are accessible to LEP persons, translation and interpretation will be offered, free of charge and may be provided by bilingual NDOC staff, or if needed, NDOC staff may contact one of our partnering community-based and systems-based programs for further translational assistance. In the event that translation services or an interpreter is needed in a language that staff or our service provider partners are not qualified in, NDOC has access to other resources, such as those included as the State of Nevada's Master Services Agreement vendors.
